The Government of Republic of Maldives represented by Ministry of Environment, Climate Change and Technology has received financing from the Green Climate Fund (GCF) for the project to Support vulnerable communities in Maldives to manage climate change-induced water shortages, and intends to apply portion of the financing for eligible payments under the contract for the project "[Civil works of Regional Laboratory in HDh.Hanimaadhoo]". The Ministry now invites sealed bids from eligible and qualified bidders for this project.
