## **Legal Officer**

The Government of the Republic of Maldives has received grant funds under the multi-donor Strategic Climate Fund, administered by the World Bank, towards the cost of Accelerating Sustainable Private Investment in Renewable Energy (ASPIRE) Project and intends to apply part of the proceeds of this grant to eligible payments under the contract for the services of a **Legal Officer** for the Project Management Unit (PMU), established within the MEE.

The key objective of this assignment is to provide legal support to the Ministry, in particular for the ASPIRE project by overseeing the legal aspects with regard to the implementation of the ASPIRE project as a whole, and its sub projects to be developed and implemented under the project.

Key qualifications of the individuals who apply for the position are:

- Minimum Undergraduate Degree in Law;  
Training in field will be an added advantage.
  - Minimum 8 years of experience working in a related position;
  - Experience in both the government and commercial sector is preferred;
  - Experience of working in donor-aided projects is desirable;  
Knowledge and understanding of technical, commercial and legal aspects of World Bank- financed projects will be an added advantage.
  - Must be result oriented and proactive. Ability to manage targeted indicators.
  - Strong communication skills in presenting, discussing and resolving difficult issues. Ability to work efficiently and effectively in a multidisciplinary team.

In addition to the above the successful candidate must be willing to work for extended periods without direct supervision.
