

1. Background

- ongoing national and Atoll-based programs/project initiatives related to the project and the site; and identify potential for collaboration, local consultations with Atoll and island councils, suggest delineation of the proposed Marine Management Area, investments sites e.g. with (t.b.) selected islands, etc. (14 days, March 2018)
