INVITATION FOR BIDS

Civil works of Regional Laboratory in HDh.Hanimaadhoo

The Government of Republic of Maldives represented by Ministry of Environment, Climate Change and Technology has received financing from the Green Climate Fund (GCF) for the project to Support vulnerable communities in Maldives to manage climate change-induced water shortages, and intends to apply portion of the financing for eligible payments under the contract for the project “[Civil works of Regional Laboratory in HDh.Hanimaadhoo]”. The Ministry now invites sealed bids from eligible and qualified bidders for this project.

The bidder shall be a listed member of the National Contractors Registry and shall satisfy the grade **GC01-01, GC01-02, GC01-03, GC01-04 and GC01-05** in order to be eligible to participate in this tender

International competitive Bidding (ICB) will be conducted in accordance with the Public Finance Regulation of Maldives, Single Stage Dual envelope bidding procedure under ICB. Qualifications requirements are stated in the Bidding Document.

Late bids will be rejected.
