*Previous announcement, Ref No: (IUL)438-GCF/438/2021/311 dated 24<sup>th</sup> October 2021, we would like to cancel the previous announcement and re-invite interested eligible consultants to submit their Proposals*

The Government of Republic of Maldives represented by Ministry of Environment, Climate Change and Technology has received financing from the Green Climate Fund (GCF) for the project to Support vulnerable communities in Maldives to manage climate change-induced water shortages, and intends to apply portion of the financing for eligible payments under the contract for the project “[**Civil works of Regional Laboratory in HDh.Hanimaadhoo**]”. The Ministry now invites sealed bids from eligible and qualified bidders for this project.

The bidder shall be a listed member of the National Contractors Registry .

**National Competitive Bidding (NCB)** will be conducted in accordance with the Public Finance Regulation of Maldives, Single Stage Dual envelope bidding procedure under NCB. Qualifications requirements are stated in the Bidding Document.
