#### **Eliminating Persistent Organic Pollutants Through Sound Management of Chemicals Project**

Due to inadequate response to the previous announcement, Ref No: (IUL)438-ENV/438/2019/261 dated 23 September 2021, we would like to cancel the previous announcement and re-invite interested eligible **Consultants** (company/partnerships/institutions/Joint Venture/sole proprietorship) to submit their Proposals.

The Government of Republic of Maldives represented by Ministry of Environment, Climate Change and Technology (MoECCT) has received financing from Global Environment Facility (GEF) and intends to part of the proceeds towards procuring the services of a **Consultant** (company/partnerships/institutions/ JV/sole proprietorship) to develop guidelines and standards for handling of hazardous chemicals along their life cycle (import, storage, use, and disposal), with focus on Best Available Techniques/Best Environmental Practices (BAT/BEP) for Poly Chlorinated Bi-Phenyls (PCBs) and unintentional Persistent Organic Pollutants (u-POPs) developed. The Ministry now invites sealed bids from eligible and qualified bidders for this project.
