Introduction and Background

The Government of Republic of Maldives represented by the *Ministry of Environment and Energy* (MEE) has allocated funds under the project Strengthening Low Carbon Energy Island Strategies (LCEI) and intends to procure services of an individual National consultant to conduct "Selection of a Public Building for Demonstration of Cost Effective Energy Efficiency Renovation and Energy Management".

The Project "Strengthening Low Carbon Energy Island Strategies Project (LCEI)", implemented by Ministry of Environment and Energy (MEE) with support from UNEP and funded by the Government of Maldives and the Global Environmental Facility (GEF) aims to reduce greenhouse gas (GHG) emissions through energy efficiency in the building sector. The project will focus on increasing energy efficiency in the building sector by developing appropriate policies, guidelines and standards and through public education and advocacy. The project aims to contribute to: (1) the transformation of markets for energy efficient technologies in buildings and the built environment in the Maldives; and (2) the promotion of energy efficiency investments in buildings. The project will not only target energy efficient technologies, but will also promote emerging low carbon energy technologies for the building sector.

Currently, the building sector is not monitored for its energy efficiency performance. Buildings seen in the Maldives are mostly without energy conservation and efficiency measures. During the project development stage, this has been identified as due to the diffused responsibility for energy consumption over the lifetime of the building. International statistics suggest that 40% of global energy is used in buildings and 60% of the world's electricity is consumed in buildings and the building sector is the largest contributor to global GHG emissions.

Maldives energy supply and demand survey (2010-2012) indicates that specific electricity consumption is highest in the Greater Male' region, at 2,730.22 kWh/person/year, 1060.27 kWh/person/year for the other atolls. This reflects both the higher level of urbanization in the Greater Malé region, as well as the significance of domestic energy use

Hence, energy efficiency and conservation measures are necessary at the national level and will largely contribute to reduce fossil fuel usage and will reduce GHG emissions.

Scope of Works

The scope of this activity is to assess the following public buildings and select one building for the demonstration of energy efficiency and energy management measures.

- 1. Green Building (Ministry of Environment and Energy and Environmental Protection Agency)
- 2. IGMH new building.
- 3. National Museum building
- 4. Maldives Meteorological Service building.

Indicative Tasks

The consultant is encouraged to include additional factors in the final report beyond the descriptions outlined below if they believe it will add to the quality of the final deliverables.

- 1. Review relevant documents including LCEI project document.
- 2. Identify Building profile –

- 3. Identify Building envelope characteristics materials used, insulation types and properties, windows, any features on windows, shading, ventilation, roof and roof insulation properties.
- 4. Determine baseline energy profile of the building the types of energies being used in the building, the total energy cost (segregated by the types of energies, energy usage pattern over the past one year period, determine the corresponding CO2 emissions and the Energy Usage Intensity of the building.
- 5. Appliances stock taking of appliances used in the buildings and their average electrical power ratings

- 6. Conduct a walk through audit and observe the various operations, focusing on the major energy consuming appliances and assess operating characteristics, usage, operating and maintenance procedures. Identify the energy efficiency measures taken in the building to reduce energy usage.
- 7. Recommend possible low cost/no cost energy efficiency interventions
- 8. Recommend possible capital improvements to make the building more energy efficient
- 9. Simple cost and benefit analysis of the identified energy efficiency/energy conservation measures.
- 10. Recommend ways to decrease roof heating by assessing the following methods;
 - Roof top solar installation potential: Should conduct a roof load assessment to verify the structural loading capacity of the building
 - o Green roof
 - \circ Roof insulation
- 11. Compare the buildings assessed with an agreed criteria finalized with the client and provide a proper justification for the selection of the building for the demonstration of energy efficiency and energy management measures – Minimum criteria while comparing the buildings are:
 - Ease of public access (for tours after the implementation of energy efficiency measures)
 - o GHG reduction potential
 - \circ Wide range of energy efficiency measures can be taken at the building

Reporting Obligation

Regular status updates of work progress must be provided to the Project Management Unit via meetings and/or email.

Deliverables

- 1. Report: "Selection of a Public Building for Demonstration of Cost Effective Energy Efficiency Renovation and Energy Management"
 - Final report format:
 - The final report must contain appropriate tables of data and graphical presentations of meaningful information gathered from the analysis of data
 - Pictures of places surveyed must be presented in the report to support explanations and recommendations.
- 2. All data collected for this assignment organized in excel sheets
- 3. All other evidence, such as pictures, collected during the assignment appropriately organized and labelled.

Duration of the Consultancy

Duration of the assignment is 45 calendar days upon signing the contract.

Requirements for Experience and Qualification

The following are a minimum requirement for the works specified in this terms of reference.

- Minimum Bachelor's degree in an energy or building services related field such as building services engineering, civil engineering, electrical engineering, , Relevant higher qualifications will score higher marks
- Minimum 3 years work experience in energy sector. Experiences related to energy auditing and the tasks indicated in this assignment must be indicated clearly in the CV.
- Experienced in data analysis must be specified in the CV
- Must have experience in working with different stakeholders
- Must have excellent presentation and report writing skills.
- Must have excellent written and oral communication skills in both Dhivehi and English
