1. INTRODUCTION

The Ministry of Environment and Energy intends to procure the services of a consultant to Develop the Environmental Impact Assessment (EIA) Report for the establishment of an Island Waste Management Centre (IWMC) at GA. Nilandhoo, Maldives.

- Undertake submission and provide any clarifications where as necessary to the submitted EIA
- Accommodate any request by EPA for any additional information regarding the submitted EIA report.
