Minister's Foreword

The Maldives has always been exemplary in fulfilling the obligations of the Montreal protocol on substances that deplete the ozone layer. Over the last 15 years we have already phased out several ozone depleting substances. This includes Chloroflorocarbons (CFCs) in 2008, two years before the target, and Hydrocholoroflorocarbons (HCFCs), 10 years in advance at an accelerated rate, with a schedule more stringent that the one set out by the Member countries.

Maldives has ratified the Kigali Amendment which proposes to phase down the production and usage of hydrofluorocarbons (HFCs) by mid-2040. The Amendment will be an important catalyst in mitigating the



negative impacts of climate change, as its achievement could help to reduce the global temperature rise by 0.5 degree Celsius by the year 2100.

Building on this success, this report is the result of further efforts to identify key stakeholders, analyse the policy and market readiness to implement the Kigali Amendment in the Maldives, and recommend a national action plan with regards to HFC phase-down.

This report provides a clear insight on the current HFC usage in the country and see where the policy gaps are, where to strengthen the regulations and initiate work on priority areas. It is a stepping stone to create an enabling environment for the cooling and refrigeration industry of the Maldives to adopt zero ODP and low GWP alternatives.

In this regard, a coordinated effort in capacity building for major industries to adopt alternative technologies, implementing import quota and license, data monitoring and reporting systems and ensuring all national strategies coherently address the implications of the Kigali Amendment will be key to successfully phasing out HFC.

The government of Maldives remains fully committed to implement the obligations of Kigali Amendment and take all necessary actions to mitigate the negative impacts of climate change.

1. INTRODUCTION

As the global hydrochlorofluorocarbon (HCFC) phase-out is progressing, their alternatives that have zero ozone-depleting potential (ODP), such as hydrofluorocarbon (HFC), hydrofluoroolefin (HFO), hydrocarbon (HC), ammonia (NH3), and carbon dioxide (CO2) are gradually being phased in.

HFCs have become the major replacement for HCFCs over the last decade due to their features like low or non-flammability, chemical inertness, relatively low cost, and excellent performance as refrigerants, foam blowing agents, aerosol propellants, or solvents. However, the most used HFC substances and blends are powerful greenhouse gases (GHG) that have high global warming potential (GWP). Therefore, uncontrolled growth in HFC use combined with growing global heating and cooling demand is expected to contribute to climate change significantly. If business as usual continues, it is estimated that HFC emissions will be equivalent to 9-19 percent of total global carbon dioxide (CO₂) emissions by 2050¹.

Accordingly, at the 28th Meeting of the Parties in October 2016, the Parties to the Montreal Protocol on Substances that Deplete the Ozone Layer agreed on the Kigali Amendment², which extended the list of the Protocol's controlled substances to include 18 HFCs. The Amendment also established phase-down schedules for HFC production and consumption. HFC consumption according to the Protocol is defined as production plus imports minus exports of HFCs expressed in CO₂ equivalent (CO₂e). The Parties decided on different phase-down schedules for two groups of Article 5 Parties: Group 1 to achieve 80% phase-down in HFCs by 2045 with the freeze starting in 2024; and Group 2 to achieve 85% phase-down in HFCs by 2047 with the freeze starting in 2028. The Republic of Maldives is classified as an Article 5 Group 1 country. The Kigali Amendment entered into force on 1 January 2019. Globally, the HFC phase-down can help avoid up to 0.4 degrees Celsius of global temperature rise by 2100.

The Maldives is a party to the Montreal Protocol and has ratified the Kigali Amendment. It is thus important for the Maldives to understand the implications that the Amendment will have on the country, including the current situation in terms of policies and institutions, market and

servicing sector, and gaps and needs for the country to effectively implement the Amendment.

1.1. Country background

The Maldives is a tropical country made up of 1,190 coral islands spread around 90,000 square kilometers. The islands are divided into 19 atolls. Around 150,000 people, or a quarter of the national population, reside in the capital city Male making it one of the world's most densely populated cities.

The economy has been growing at an annual rate of 10% for the past two decades and the GDP per capita was last recorded as USD 11,890 in 2018³. Tourism is the main industry which accounts for almost 31% of the GDP. Building and construction and the fisheries industries follow closely behind. The refrigeration and air conditioning (RAC) sector has seen exponential growth due to the rising standard of living, expanding tourism, and fish exports.

The Maldives only imports and does not produce or export any ozone-depleting substances (ODSs) or any other refrigerants. In the Maldives, ODSs are mainly used for RAC equipment servicing. The residential and commercial sectors are the largest consumers of RAC equipment in the country followed by the tourism sector. However, the Maldives' national average consumption of ODS is within 300 grams per capita and it is a Low Volume Consuming (LVC) country.

As a Party to the Montreal Protocol, the Maldives has phased out chlorofluorocarbons (CFCs) in 2008 and is currently implementing measures to phase-out HCFCs by 2020. As a result, the consumption of HFCs which are used as their alternatives has been increasing significantly over the past 15 years.

1.2. The Maldives's ratification of the Montreal Protocol and its Amendments

The Maldives is a party to the Vienna Convention for the Protection of the Ozone Layer and the Montreal Protocol. It has ratified all the amendments to the Montreal Protocol, including the Kigali Amendment. The Maldives was the twelfth country to ratify the Amendment, having ratified it on 9 November 2017. It has also ratified all the major international agreements related to climate change.

As an Article 5 country under the Montreal Protocol, the Maldives is entitled to receive financial support from the Multilateral Fund for the Implementation of the Montreal Protocol (MLF) and technical support from the international community to support its activities to implement the Montreal Protocol.

1.3. The Maldives' ODS phase-out achievements

As a signatory to the Montreal Protocol, the Maldives has implemented several programs to phase-out the consumption of ODSs according to the targets set by the Protocol.

The Country Programme (CP), which was prepared by the Ministry of Planning and Environment in April 1993 and approved at the 10th Meeting of the Executive Committee of the Multilateral Fund (EXCOM) in June 1993, helped the Maldives to put in place policy measures such as the control on the importation of ODS and their products, labelling of ozone-friendly products, duty exemptions for recycling and recovery equipment and a government subsidy at 30 percent of the cost for every recycling recovery units. It also facilitated the industry to implement projects in the refrigeration sector.

The Institutional Strengthening (IS) project, also funded by the MLF, has helped the Maldives to establish the National Ozone Unit (NOU). The IS program commenced in January 1995 and continued until today through subsequent project renewals. The IS project supports the operation of the NOU, public awareness activities, information exchange, and training and monitoring programs.

Through the Refrigerant Management Plan (RMP), the Maldives trained more than 100 servicing technicians, provided one recovery machine to a training center, trained a total of

140 customs officers, and provided nine CFC detecting toolkits to the Customs Service. The RMP also helped the Maldives provide awareness programs for end-users and training for technicians in the mobile air-conditioning (MAC) sector, procure recovery and recycling equipment, some of which were provided to the Faculty of Engineering of the Maldives College of Higher Education. The conversion of the MAC systems and the end-user incentive program were the most successful components of this project which was completed in 2006.

In January 2003, the Maldives banned the importation of the following ODSs: halons, methyl chloroform, bromochloromethane, methyl bromide, and carbon tetrachloride. A ban on the importation of equipment containing CFC-11 and CFC-12 followed a year later with Public Announcement made on 27 May 2003. Equipment banned included refrigerators, deep freezers, water coolers, mini-bars, and motor vehicles manufactured before 1998 that contain CFCs in their air conditioning units.

The Maldives focused on capacity building and provided training on good practices in refrigeration to 67 technicians in the tourism and fisheries sectors via the CFC Terminal Phase-out Management (TPMP). The Maldives also trained enforcement officers to strengthen the control of ODS import and export and provided 5 CFC identifiers to the Customs Service.

These combined efforts enabled the Maldives to completely phase out CFCs in 2008, two years ahead of the Montreal Protocol schedule, and helped lay the foundation to phase out HCFCs.

The HCFC Phase-out Management Plan (HPMP) was approved at the 60th Meeting of the Executive Committee in 2010. The Plan aims at phasing out HCFC consumption by 2020 at an accelerated rate agreed between the Maldives and the MLF, per the below schedule. This schedule is even more stringent than the schedule set out in the Montreal Protocol.

The Maldives implemented the HPMP starting with the control of HCFC import in 2011. The plan has been implemented successfully with the engagement of all key stakeholders and the close collaboration between the NOU and the customs. Some notable achievements under the HPMP include the publication of the first Ozone Act and the amendment of the Import-Export Act⁴ under the Ministry of Economic Development to apply tax incentives and disincentives related to the import of ODSs.

Thanks to these efforts, having allocated the final quota of 1.68 metric tonnes for 2020, the Maldives achieved a 97.5% reduction in HCFC consumption in 2020 with a 2.5% tail for servicing use until 2025.

1.4. The context, objective, and methodology of the Country Assessment Report

The EXCOM, at its 79th meeting in July 2017, adopted Decision 79/46 on Enabling Activities for Article 5 countries to facilitate the early ratification of the Kigali Amendment and to support the countries to fulfil the initial obligations related to HFC phase-down. The Enabling Activities for the Maldives was approved at the 80th Meeting of the EXCOM in November 2017 with UNEP as the implementing agency.

The Maldives' Enabling Activities project aims to enhance country ownership of the Kigali Amendment and ensure a smooth implementation by assessing the readiness of different sectors to adopt zero ODP and low GWP alternatives. More specifically, the activities include developing the Country Assessment Report; capacity building for key stakeholders; facilitating tourism and fisheries sector to adopt alternative technologies; identifying training needs for handling HFC alternatives in different sectors; implementing import quota and license and data monitoring and reporting systems and ensuring all national strategies coherently address the implications of the Kigali Amendment.

The objective of this Country Assessment Report, prepared as part of the Enabling Activities project, is to identify key stakeholders, analyze the policy and market readiness to implement the Kigali Amendment in the Maldives, and recommend a national action plan. More specifically, the Report consists of:

- Assessment of HFC consumption in relevant sectors based on customs import statistics. This includes residential and commercial sectors and tourism and fisheries sectors. The hospitals and healthcare centers have been grouped into residential and commercial sectors.
- Analysis of existing policies related to ODS, climate change, and other relevant sectors to draw the linkages and identify gaps that need to be filled to implement HFC phasedown.
- Assessment of feasible and viable technologies for the Maldives and the conditions needed to be met for smooth introduction and adoption of low GWP alternatives.
- Identification of gaps in the existing import quota and licensing system and recommendation on ways to include HFCs and improve the existing system, for instance, the use of Single Window System (Makudi run by the Ministry of Defense).
- Identification of challenges and gaps in the current data collection, monitoring, and reporting system and recommendation on ways to improve it while extending the system to cover HFCs.
- Identification of key national stakeholders of the Kigali Amendment and recommendations on ways to raise awareness and engagement.
- Identification of gaps in regulating the servicing sector and recommendations for improvement.

The Country Assessment Report, as a comprehensive key report under the Enabling Activities project, covers most aspects of the project's components. The development of the Report facilitated and contributed to the implementation Enabling Activities project as a whole and built on the outputs of its components.

Consultations with policymakers during the Report's development process helped also to raise the awareness of the policymakers on the country's obligations, challenges, and recommended activities to implement the Kigali Amendment in the Maldives.

The following activities were conducted by the NOU to develop this country assessment report:

- Two national consultants were hired to conduct the market and policy analysis. The market analysis consultant worked from May 2019 to April 2020 and the legal consultant worked from September 2019 to February 2020.
- Examined the existing ODS import quota and licensing system and identified gaps.
- Identified challenges in the customs procedure in the import process.

- Conducted one stakeholder consultation on 24 November 2019 with key stakeholders to gather information and to share the findings of the initial market analysis. The validation workshop was scheduled to take place in April 2020 but had been delayed due to the Pandemic and was conducted online in February 2021.
- Conducted a workshop with tourism industry professionals on 24 February 2020 to develop an initial plan to facilitate the HFC phase-down.

The market and RAC servicing sector needs assessment was done mainly through desk research and field surveys. All surveys were conducted by the market analysis consultant from the Maldives Institute of Technology (MIT). Structured questionnaires were developed and used for each target group. The table below maps out the stakeholders who were consulted and the type of data gathered.

The sample survey approach was used for the field surveys conducted. The sample size and the percentage of its representation are shown in the table below. The survey questionnaires were sent to all the resorts from all over the country in the directory provided by The Maldives Tourism Development Corporation. And the survey questionnaires/ forms were completed by 23 resorts.

As for the servicing workshops, it was not possible to know the total number of workshops, as there is no comprehensive list of workshops that provide RAC servicing in the country.

However, only 3 servicing workshops sent back the answered survey forms, and the data was incomplete.

2. THE KIGALI AMENDMENT AND ITS IMPLICATIONS TO THE MALDIVES

2.1. The Kigali Amendment obligations applicable to the Maldives

The Maldives ratified the Kigali Amendment in September 2017 and the Amendment entered into force for the Maldives in January 2019. Therefore, the Maldives needs to reduce the consumption of HFCs, whether as a single substance or as composition in any mixtures, according to the phase-down schedule set out in the Amendment for Article 5 Group 1 countries, shown in the table below.

The HFC phase-down implementation for the Maldives will start in 2024, with the freeze in HFC consumption from January 2024 at the baseline level, and ultimately phasing down 80% of its HFCs consumption from the baseline by 2045. CO₂ is used to measure the consumption baseline and emission from HFCs. Since the Maldives imports 100 percent of the refrigerants

used in the country and does not produce or export any HFCs, the country's HFC consumption equals its HFC import. The country, therefore, needs to control its HFC imports to reduce its HFC consumption.

In addition to the phase-down obligation, the Maldives needs to provide accurate reporting of HFC consumption data annually as per Article 7 of the Montreal Protocol. Reporting must start for the year the Kigali Amendment enters into force for a country. The Maldives, therefore, has started reporting HFC consumption data from 2019.

Further, the Maldives must establish an effective licensing system to control the import and export of HFCs as per Article 4B of the Montreal Protocol, by 1 January 2021.

2.2. The benefits of implementing the Kigali Amendment

The benefits of implementing the Kigali Amendment in the Maldives include:

- Showing commitment to global climate change and ozone layer protection efforts and contributing to GHG emissions reduction. The early ratification of the Kigali Amendment by the Maldives has demonstrated the country's commitment to addressing the issue of global environmental challenges.
- Moving away from HFC can be an opportunity to leapfrog from high GWP-based equipment to low GWP-based equipment that is also more energy-efficient. This can bring additional climate benefits by reducing energy use in RAC equipment.
- As an Article 5 country that has ratified the Kigali Amendment, the Maldives has access to international financial and technical support through the MLF to support its efforts in improving the capacity of the national stakeholders to reduce HFC consumption.
- As the Maldives ratified the Kigali Amendment, it will avoid HFC trade sanctions that will be imposed on non-parties to the Amendment. As Maldives imports all HFCs and RAC equipment, it is an important aspect that will have positive implications for the country.
- The Kigali Amendment allows flexibility for each country to choose its HFC phase-down priorities. The Maldives will be able to select the types of HFCs, sectors, technologies, and alternatives to prioritize based on what is best suited for the Maldives without having to get clearance from the other Parties.
- Implementing the Kigali Amendment will be an opportunity to regulate the servicing sector,
 for example, through voluntary certification, which can be made mandatory overtime.

- Implementing the Kigali Amendment will also be an opportunity to strengthen the data collection and monitoring system which will, in turn, lead to better management of the refrigerants throughout the lifecycle, from importation to disposal.

2.3. The challenges and costs of implementing the Kigali Amendment

However, there will also be some challenges that should be considered and addressed:

- Resistance from the fisheries and tourism sectors due to a lack of affordable alternatives.
- Challenges in enforcing the control of the servicing sector will result in undermining the safety when using climate-friendly but flammable alternatives to HFCs.
- Disruption in the livelihoods of smaller business which offer informal servicing.

Some of the expected main administrative costs include costs related to activities outlined below:

- Surveying existing HFC consumption to better understand the HFC use situation in the country. The data currently available is limited to customs import data.
- Developing the resources to ensure accurate and timely reporting of HFC consumption.
- Amending the existing policies or introducing new ones to include the HFC phase-down obligations. These include various policies on ODS control, climate change, energy efficiency, and safety.
- Extending the existing ODS import quota and licensing system to cover HFCs.
- Capacity building for customs officers to control HFCs.
- Providing training for technicians to handle HFC alternatives that are flammable or toxic (HFC-32, HC-290, HC-600a, R-717, etc.).
- Further developing the single window Makudi System to ensure all permits and licenses can be obtained online.
- Purchasing tools needed to handle HFC alternatives such as HFOs, HCs, and natural refrigerants.
- Engaging additional stakeholders under the Kigali Amendment regime.
- Developing national strategies and action plan for HFC phase-down.
- Attending any additional international meetings relevant to the Kigali Amendment.

It should be however noted that the MLF provides funding to support Article 5 countries in the implementation of the Montreal Protocol and its amendments. The established Trust Fund for the Montreal Protocol also supports the participation of key national decision-makers of Article 5 countries in international meetings. Therefore, it is expected that no substantial additional cost will incur for the Government of the Maldives. The initial support provided by the MLF through the Enabling Activities project which covers some of the costs related to the activities mentioned above is expected to be followed by further technical and financial assistance for the country to build its capacity for the phase-down of HFC.

3. MARKET ASSESSMENT

3.1. Consumption of HFCs

The Maldives is a Small Island Developing State with a population of 545,000. The climate is hot and humid and there is a high demand for cooling throughout the year. Over 30 percent of the population resides in the capital city, Male, which is one of the world's most densely populated cities. Over the last decade, the Maldives has developed exponentially with considerable improvements in the country's infrastructure and connectivity. In 2018, its GDP reached USD 11,890, from USD 200 in 1978 according to the World Bank⁵. The standard of living has increased significantly which has led to an increased demand for cooling.

With its unique geography and pristine beaches, tourism and fisheries are the main backbones of the economy. Since the 1970s, the tourism industry has been growing steadily. Over the past five years from 2014 to 2018, tourism accommodation facilities and their bed capacity have been increasing at an annual average rate of 14.3% (Tourism Yearbook, 2019). As of 2019, there have been 19 new resort developments with a bed capacity of 4501 beds. Currently, there are 164 resorts, 11 hotels, and 561 guest houses, and 154 safari vessels in the Maldives (Statistical Pocketbook of Maldives, 2020)⁶.

Although the geography of the islands is the perfect tool to attract upmarket tourists, it has led to a dispersed population and proved to be a development challenge. To address this issue, the government has then reversed centralization policies to develop at least 5 regional economic hubs across the country. This means more infrastructure projects and airports for the next few years (World Bank, 2020)⁷.

As the population increases, the demand for housing continues to increase in the Greater Male Region. According to the last census in 2014, there are 68,249 households. In Male, more than 96% of households live in flats and apartments (National Bureau of Statistics, 2014)⁸. In efforts to decrease congestion in the capital city, most of the residential developments will take place in Hulhumale. Almost half of Phase Two developments are

allocated for residential developments with a target population of 140,000 (Housing Development Cooperation, 2016)⁹.

The abundance of marine life makes up the next main economic activity. Fisheries and fish processing accounted for 5.1% of the GDP in 2013. In the past ten years, this sector modernized and expanded with new, larger vessels (Food and Agriculture Organization of the United Nations, 2020)¹⁰.

Moreover, Maldives has been developing steadily and the standard of living has been increasing which means that the demand for RAC equipment is increasing and will continue to do so. Refrigerants and RAC equipment are imported into the country and are used solely for air-conditioning and refrigeration.

The most reliable data available for this report is the Customs Import Statistics. Analysis of the import statistics from 2016 to 2020 suggests that the main end-users are the tourism accommodation facilities, housing units, public procurement (airports, schools, public offices, buildings, etc.), shops, restaurants, and fish processing facilities. The main sectors are summed up in the figure below.

(canning factories, transportation vessels, freezing facilities, food and beverage storages)

Since the implementation of the HPMP in 2010, the consumption of HCFCs has been gradually dropping while that of ODS alternatives has been steadily increasing. According to the Maldives' ODS Alternatives Survey 2016, the consumption of HCFCs at the end of 2015

takes up 40% while ODS alternatives account for 60% of the total refrigerant consumed in the Maldives.

The most commonly used HFC recorded in 2016 was HFC-134A. Other commonly used HFC blends in the Maldives are R-404A, R-407C, R-410A, and R-417A which were imported every year since 2012. Occasionally consumed blends are R-507C, which was imported in 2012 and 2014 only, and R-438A which was imported in 2015 (ODS Alternatives Survey, 2016).

Ammonia is also used mainly in industrial refrigeration in the fisheries industry. According to the ODS Alternatives Survey 2016, the main consumer of ammonia was the Maldivian Industrial Fisheries Company (MIFCO). It was predicted that 6 tonnes of ammonia would be imported per year. The table below has been adapted from the ODS Survey Report.

However, the analysis of customs import statistics of 2019 shows that R-410A is now the most imported refrigerant and not the HFC-134a of before.

3.2. Supply of HFCs and their alternatives

In the Maldives, all refrigerant gases are imported and they are all imported for use in the RAC servicing sector. The refrigerants also enter the country as pre-charged gas in the imported RAC equipment but such pre-charged substances are not counted as an import under the Montreal Protocol.

As of 2019, there are 23 registered refrigerant importers. The list is given below.

According to the ODS Alternatives Survey Report in 2016, the majority of the HFCs were imported from China, Singapore, Sri Lanka, UAE, India, and some EU countries. However, according to the most recent import statistics, HFCs are imported from China, Thailand, Malaysia, and Singapore.

The figure above illustrates the amounts of refrigerants imported in 2019. R-410A is by far the most imported HFC, at 78.32 MT. It is followed by R-404A, HFC-134a, and R-407C.

The import statistics of HFCs from 2016-2020 show that the import of R-410A has generally increased. The import amount of R-404A, HFC-134a, and R-407C has been fairly consistent during the period. The presence of two HFC-23 Cascade Blast Freezers (40ft container size for rapid cooling of fish) located in Maandhoo Fisheries Enterprises was noted. However, no recent import of HFC-23 was recorded.

The next figure shows the import of natural refrigerants from 2016 to 2020. The import of ammonia has generally increased during this period.

The above figure shows the import of natural refrigerants per year from 2011 to 2020. Overall, since the implementation of the HPMP, HCFCs have been phased out and increased demand

3.3. Supply of HFC-based equipment

for HFCs and natural refrigerants can be observed.

The prevailing hot and humid atmospheric conditions, general economic growth accompanied by improvement in the quality of life in the country, and recent developments in the tourism sector have resulted in an increase in RAC units across the country. In 2009, permission to operate guesthouses on local islands was granted which lead to a further increase in tourism establishments and RAC equipment used therein. Air-conditioning is a necessity for tourists and for many people in the capital city Male, where the population is growing and dwellings are congested.

The Maldives does not manufacture any kind of RAC equipment. Instead, all equipment is imported from the countries shown in the figure below.

The customs import statistics from 2016 to 2019 indicate that the majority of RAC equipment is brought in from China, Thailand, Singapore, Malaysia, and Italy. The types of RAC equipment imported are:

• Small standalone systems: beer cooler, bottle cooler, ice cream maker, ice cube machine, ice flaker

- Chillers and refrigerators: household and non-household, deep freezers
- Blood banks
- Large freezer containers
- Air conditioners
- Mobile air-conditioning units

The equipment is imported new and pre-charged except for some of the large freezer containers, 10 percent of which are imported as refurbished.

3.4. Key applications

RAC equipment is imported for commercial purposes, for use in residential units (by construction and development companies), tourism facilities, healthcare providers, fisheries establishments, and food and beverage operators. The figure below indicates the market share of RAC equipment from 2016 – 2019 per type of equipment. It is observed that almost

70% of the RAC equipment in the Maldives is air conditioners. It is expected that the demand for air conditioners will keep rising as the climate keeps getting warmer.

3.4.1. Room air-conditioners and variant flow (VRF) system

All air conditioners (ACs) are grouped into one single category in this report as the available import statistics from customs do not account for different categories of ACs. This category includes both small to large split systems (9000 BTU to 24,000 BTU) and VRF units in different capacities.

As shown in the figure above, AC dominates the largest portion of RAC equipment in the Maldives. With the total number of RAC equipment increasing every year, AC and VRF have maintained the highest percentage at almost 70% of the total RAC equipment imported in the country. The figure below shows that the number of AC being imported into the country has increased by 9.3 percent from 2016-2019 according to customs data.

Some of the popular AC brands in the market are AUX, LG, Panasonic, GREE, and Daikin. Currently, in the Maldives, there are no ACs using HCFCs due to the ban on the import of HCFC-based equipment in 2016, except for a few remaining HCFC-based ACs that were imported before 2016.

The survey conducted on 23 resorts (out of a total of 164) indicates that 71% of the air conditioners are based on R-410A.

Approximately 35% of the total existing AC units require servicing annually which includes refrigerant charging. The average charge size required during servicing is 1 kg per unit. Most new systems are imported pre-charged and no refrigerant charging is required.

3.4.2. Domestic refrigerators and freezers

Domestic refrigerators are sold as stand-alone units. They are mostly imported from Singapore, China, Thailand, UAE, Italy, and Malaysia. Domestic refrigerators and freezers are predominantly used in residential and commercial buildings but are also used extensively in the tourism sector. The type of refrigerators and freezers in this category are:

- Combined refrigerators-freezers, with separate external door
- Compression type household refrigerators
- Refrigerator (household) other
- Freezers of chest type, capacity=<800 liters
- Deep freezer of upright type=<900 liters
- Refrigerator (blood bank)

The import statistics from 2016 to 2019 revealed that the imports for domestic refrigerators and freezers are increasing steadily, parallel to the growth of the economy.

The survey of the tourism facilities indicated that R-404A, HFC-134A, and HC-600a are the most commonly used refrigerant in this sector.

3.4.3. Commercial refrigeration system - small stand-alone units

A small standalone system is refrigeration equipment that is mostly used in the tourism sector. They are also used in commercial establishments but rarely at homes and in offices. Types of equipment covered within this category are:

- Refrigerating counter and table
- Bottle cooler
- Water cooler
- Ice cube machine
- Beer cooler
- Ice flaker
- Ice-cream machines
- Beverages and liquid dispenser
- Water dispenser

The number of commercial refrigeration systems imported into the country shows an increasing trend.

Commercial refrigeration systems are imported by distributors and commercial establishments such as resorts, hotels, and guesthouses. They import different brands and mostly as new systems. They are usually pre-charged with R-404A and HFC-134a.

3.4.4. Large refrigeration system

Reefer container and freezer containers are used for transportation of food like fruit, meat, and non-food-related items such as flowers and pharmaceuticals. These containers include freezer containers (20ft and 40ft), walk-in chillers and freezers, sea freight 20 ft containers, and work table chillers. Most are imported as new and only 10% is imported as second hand. Second-hand equipment is imported from UAE, Singapore, and Sri Lanka. Importers include resort developers, food suppliers, supermarkets, fish processing companies, and plant, flower sellers.

Some of this refrigeration equipment is used within the bonded warehouse of Maldives Customs and needs to be accounted for when implementing the HFC phase-down. The objective of the bonded warehouse is to keep any goods that are permitted to be imported or exported from the Maldives. The bonded warehouse is registered under Customs and importers are allowed to store pork and pork-related products, liquor items, and winery products required by the local resorts.

As per the information gathered from an external source, a bonded warehouse is equipped with general storage as well as chillers and freezer containers. Pork and pork products are stored in freezer containers while liquor and wine products are stored in chiller containers.

Some importers have also been given extra land where they have built cold rooms and other storage facilities to cater for the imported products at the bonded warehouse.

The type of refrigerant used is not indicated and remains a gap in the data available.

3.4.5. Mobile air conditioner (MAC)

Mobile Air-conditioners (MAC) used in vehicles are an important part of the RAC equipment being used across the Maldives. Many vehicles are imported secondhand and most of these vehicles are pre-charged with HFC-134 which has high GWP. The types of vehicles within which MAC is installed are buses, cars, vans, light trucks, and heavy vehicles such as cranes, forklifts, and excavators. MAC takes up approximately 2% of the total RAC equipment imported into the country. The import statistics from 2015 to 2019 show that the import amount is generally decreasing. Many are imported second-hand.

4. REFRIGERATION AND AIR-CONDITIONING SERVICING SECTOR ASSESSMENT

4.1. RAC servicing workshops

HFCs in the Maldives are used mainly in the RAC servicing sector. However, the servicing sector remains largely unregulated since the Maldives currently does not have a regulation that controls the opening of a RAC servicing workshop nor a registration system for RAC service workshops. Any business or company registered in the Ministry of Economic Development can provide servicing for RAC equipment. This makes it challenging to provide the exact number of RAC servicing workshops operating in the country.

The majority of the workshops are located in Male and most resorts have their in-house technicians to service the RAC equipment. Out of the roughly estimated 260 workshops that provide RAC servicing in the Maldives, none are registered as RAC servicing workshops for the reasons mentioned above. It is estimated that about 80% of the workshops engage in the repair and maintenance of domestic RAC equipment, and the remaining 20% provide servicing for commercial RAC equipment. Only a limited number of workshops provide servicing for commercial equipment as they require properly trained technicians with more skills, knowledge, and tools.

It is estimated that only about 30% of servicing workshops can provide good servicing practices. This was calculated based on the percentage of technicians who have participated in either long-term or short-term training programs on the repair and maintenance of RAC.

4.2. RAC servicing technicians

There is currently no regulation that mandates a practicing license or certificate for RAC technicians. Hence any person can offer RAC servicing, and the practice remains largely unregulated.

Approximately 1,300 technicians are working in the RAC servicing sector in the Maldives. Most of the technicians lack formal qualifications or have qualifications that are not formally recognized. In the Maldives, approximately 70% of the technicians are expatriates, coming mainly from Bangladesh and Sri Lanka. As there is not a mandatory registration or certification system, it is not possible to categorize the percentage of certified technicians. However, based on the number of students who have undertaken the training of Maldives National Qualification Framework (MNQF) certificate level III from any of the training institutes across the country, it is estimated that on average, 30% or about 390 technicians in the RAC servicing workshops have the level III certificate whereas the remaining 70%, or 910 technicians, do not. Expatriates can join the courses offered, however, the language barrier is a challenge, and therefore they do not join very often.

The servicing sector survey conducted by the Maldives Institute of Technology (MIT) as part of this study found that the servicing technicians in the Maldives handle HFCs such as R-410A, HFC-134a, R-404A, and R-407A. The only low GWP technology that the technicians have had used during servicing recently is HC-600a.

Although there is RAC equipment based on flammable refrigerants such as HC-600a and HC-290 in the market, the knowledge, and skills related to the safe handling of flammable refrigerants are limited as the technicians lack formal education, and the majority of them do not follow good practices in servicing.

4.3. Maldives National Qualification Framework for RAC technicians training

In the Maldives, there is an increasing number of private education providers catering to the post-secondary education sector. Due to the increasing demand, the Maldives Qualification Authority (MQA) developed the Maldives National Qualification Framework (MNQF) to facilitate quality assurance in the post-secondary education sector. It also acts as the framework to recognize the qualifications offered locally and internationally.

To improve the quality and relevance of post-secondary education and training in the Maldives, the MNQF incorporated a broader and more cohesive technical and vocational qualification system. This provided the opportunity to include more sustainable and strategic solutions to cater to national human resource development needs.

The MNQF has ten levels: level 1 (certificate I) is the lowest and level 10 (Ph.D.) the highest. The MNQF includes all post-secondary school qualifications from the initial certification to advanced academic, technical, and professional qualifications. Certificate I recognize the acquisition of core entry-level skills for a new worker. Certificates II, III, and IV recognize increasing levels of capability and competence through to the fully qualified person. Diplomas, advanced diplomas, and higher diplomas recognize technician, technologist, managerial and professional level skills and knowledge. Qualifications can be achieved through learning in institutions and the workplace.

As of now, RAC equipment servicing programs exist between levels 3 and 5. Based on the review of all the curriculums, level 3 qualification target the development of knowledge and skills related to servicing domestic equipment while level 5 targets servicing commercial equipment used in cold storage and food and beverage outlets.

4.4. Training institutes for RAC technicians

4.4.1. Training curriculum

There are a total of three institutes that provide RAC servicing-related training in the Maldives.

Maldives Polytechnic is run by the government while the others are private institutions.

A review of the training curricula of the three institutes showed that the existing programs in each level provide the following training:

- **Certificate Level-III**: focuses on the repair and maintenance of split systems, domestic refrigerators, and water coolers.
- **Certificate Level-IV**: provides knowledge and skills related to commercial refrigeration.
- **Diploma**: focuses on developing the conceptual knowledge of RAC and covers both domestic and commercial RAC equipment.

The curricula of the RAC courses offered by the institutes are prepared using the MNQF guidelines. They are developed based on the contributions from trainers, in-house technicians, field experts, industry personnel, and any relevant institutions. Furthermore, the curricula are updated based on surveys, references to other universities, advice from consultants and industry experts, and feedback from workshops.

MIT and Maldives Polytechnic offer courses on RAC servicing for all types of RAC equipment: residential, commercial, individual, and MAC. TVEC only offers RAC servicing in the residential sector equipment.

Regarding refrigerators, all three institutions include residential equipment in their training. Two institutions cover commercial refrigerators, refrigeration racks with separate condensing units, and central refrigeration systems in their training programmes.

The types of refrigerants covered in the training programmes for refrigerators are HCFC-22, HFC-134a, R-404A, R-600a, and R-744. All three institutions cover HCFC-22, HFC-134a, and R-600a. Two institutions cover R-404A, and only one covers R-744. R-507A and R-717 are not covered by any institute.

Regarding ACs, all three institutions cover room ACs - small split systems up to 3 TR), multi splits with single outdoor units, and chillers. Two institutions cover room ACs - window units. Only one institution covers room ACs - medium split systems up to 6TR, central ducted system /VRF systems, and MACs.

The types of refrigerants covered in the training programmes for ACs are HCFC-22, HFC-134a, HFC-32, R-407C, R-410A, and R-290. All three institutions cover HCFC-22, HFC-134a, R-410A, and R-407C. Only one institution covers HFC-32 and R-290.

The table below shows the main topics covered under the training programmes in all three institutions.

Overall, all three institutions include the same topics in their training programmes. However, TVEC offers more training hours than MIT.

In addition, the good servicing practices module for RAC developed by UNEP is part of the course in MIT and TVEC. Maldives Polytechnic does not include the good servicing practice module.

However, the existing programs lack training on how to handle flammable refrigerants. There is also a lack of training on the impact of RAC servicing on the environment, and many graduates lack the knowledge of the Montreal Protocol and the global efforts to phase out HCFCs and HFCs.

4.4.2. Students

From 2014 to 2018, there have been a total of 698 graduates from all 3 institutions. MIT had the most recorded number of students while Maldives Polytechnic had 167 graduates during this period. TVEC only provided information for 2018, which was 31 students. MIT stated that most students find work in the construction sector after graduation.

The entry requirements into these programs are set according to the MNQF and the requirements are similar in all three institutions as they follow the MNQF guidelines.

There are between 1-4 students on a workbench. Students are evaluated by practical and written tests. They are also assessed based on direct observation, logbooks, and feedback.

4.4.3. Trainers

The table-13 below shows the number of trainers at each institute. And table-14 shows the trainers' qualifications, years of training experience, and years of experience in working with natural refrigerants.

Based on the survey, trainers have an average of 16 years of experience. Their education qualifications ranged from advanced certificate to Masters, and there was one trainer without

education qualification. The five trainers who specified to have experience in hydrocarbon, ammonia, and CO2 systems have between 5 to 20 years of experience.

In terms of the trainers' participation in training offered by the NOU, trainers from MIT and TVEC have received training from the NOU. Some of the subjects covered during the training are recovery and declining, hydrocarbons, district cooling, retrofit, and reclamation.

4.4.4. Tools for training

The table below summarizes the tools available at training institutes for training during practical sessions.

4.5. Initiation of the licensing system for the servicing technicians

The Ministry of Environment, Climate Change and Technology (MOECCT) in collaboration with UNEP, pilot tested the Refrigerant Driving License (RDL) program in the Maldives in 2019. RDL is a globally recognized and accepted qualification program that sets minimum requirements for the proper and safe management of refrigerants in the RAC sector. The RDL is issued to individuals who work as RAC servicing technicians to appreciate their technical skills and competencies who have achieved enhanced refrigerant management skills, including the handling of HFC refrigerants as well as flammable and other low-GWP refrigerants, improved safety skills and servicing practices, reduced refrigerant emission during the services and increased the cost-effectiveness of the equipment and services. Two batches of students have gone through the RDL program and the program was well-received. It needs to be organized and delivered across the country to be implemented at a larger scale.

Besides, the MOECCT is currently working to introduce the local licensing system nationally. The MOECCT is currently developing the required documents and frameworks to implement this local licensing system.

5. OVERVIEW OF EXISTING POLICIES

In this report, the term policy is defined broadly to include national legislation, regulation, strategic plan, guideline, standard, and other national interventions that have the purpose of achieving certain goals set by the Government.

5.1. Policies on ozone layer protection, control of ODSs, alternatives, and RAC equipment

5.1.1. Development of key ODS policies

- Public Announcement No A-14 2002: the introduction of the import control system

The ODS import control system became effective on 1 April 2002 through the *Public Announcement No A-14 2002* dated 20 March 2002, which was made by the then Ministry of Trade and Industries. Under the then-existing Constitution, public announcements made by the government fell within the definition of law. All ODSs, including HCFCs and their blends, were covered under this Announcement. Furthermore, under this announcement, ODSs could be imported after an importer is registered with the NOU and it has obtained an import permit for each shipment from the then Ministry of Housing, Transport, and Environment. Under these rules, an import license was required to be renewed annually.

- Public Announcement No 10ERC/2002/44: the ban on import of selected ODSs

A ban on importing of certain ODSs came into effect in January 2003 through the *Public Announcement No 10ERC/2002/44* dated 19 December 2002. Under this announcement, the import of halons (1211,1301, 2402), methyl chloroform, bromochloromethane, methyl bromide, and carbon tetrachloride were banned.

- **Public Announcement No A-28-2003/44:** the ban on import of equipment containing CFCs

A year later, the import of equipment containing CFC-11 and CFC-12 were banned by way of *Public Announcement No A-28-2003/44* dated 27 May 2003. Items banned under this announcement included refrigerators, deep freezers, water coolers, mini-bars, and motor vehicles which are manufactured before the year 1998 and which contained CFCs in their air conditioning units.

- **2010 Regulation on the Management and Control of HCFCs and blends of HCFCs:** the introduction of quota and licensing system for HCFCs

The 2008 Constitution required all laws to be in the format of an act and be passed by the Parliament or be in the format of a regulation enacted under an Act and be passed by the Parliament. Therefore, a regulation governing HCFCs trade was enacted in 2010. This regulation titled *the Management and Control of HCFCs and blends of HCFCs* consisted of a phase-out schedule, required quota allocation, and licensing of importers.

5.1.2. Measures to Protect the Ozone Layer Act 2015 and the Regulation on Chemical Substances and Various Equipment that Harm the Ozone Layer 2017

Measures to Protect the Ozone Layer Act (Law Number 41/2015) became effective on 6 December 2015, abolishing the 2010 Regulation explained above and broadening the scope of its provisions to cover not only ODSs but also ODS alternatives.

The 2015 Act obliges the MOECCT to formulate all necessary regulations and guidelines that are required to be formulated according to the Act. Hence a regulation titled the *Chemical Substances and Various Equipment that Harm the Ozone Layer* (Regulation Number: R-9/2017) was further introduced on 22 January 2017 to provide additional provisions on the control of ODS and ODS alternatives, including an import permit system for HFCs and other ODS alternatives. The primary government agency responsible for the monitoring and administration of the 2015 Act and the 2017 Regulation is the MOECCT.

The 2015 Act, since its introduction on 6 December 2015, bans the import of substances that are under Annex A, Annex B, Group III of Annex C, and Annex E of the Montreal Protocol. Furthermore, under the 2015 Act, all substances under Group I of Annex C of the Montreal Protocol are stipulated as controlled substances. Controlled substances can be imported with prior approval from the MOECCT. Amongst the controlled substances provided in the 2015 Act, only HCFC-22 is imported into the Maldives.

Additionally, the 2015 Act provides for a complete ban on imports of equipment that are based on banned or controlled substances in the 2015 Act. This ban on the import of equipment became effective on 31 May 2016.

The 2015 Act further stipulates that any ODS alternatives to banned and controlled substances provided in the Act shall only be imported upon receiving a prior permit from the MOECCT. This hence applies to HFCs as well.

One of the hallmark features of the 2015 Act is that it takes a phase-down approach concerning the import of controlled substances determined under the Act. The following table which provides the phase-down timeline is included in Annex 3 of the 2015 Act.

5.1.3. Import quota system

The 2015 Act and the 2017 Regulation have provisions to control the import of controlled substances by imposing quota limits. Under the 2017 Regulation, the MOECCT is required to announce the quota by 15 December of the preceding year to which the import quota is applicable. The quota limit for every year is determined according to the phase-down timeline table provided in the 2015 Act. The MOECCT announces the annual quota limit by publishing a public notice¹¹.

Thereafter, importers interested in obtaining a quota for the import of controlled substances must submit all the information and proposal as required by the Ministry. Quota determined by the Ministry is allocated to parties that submit the most adequate proposal among the applicants.

The quota is awarded according to the procurement rules provided in the Public Finance Act (Law Number: 3/2006)¹² and its regulation. The procurement rules under Public Finance Act followed in this process mandate the authorities to publicly announce the call for proposals for importers and to evaluate each proposal. The announcement is made by the MOECCT and the proposals that are submitted pursuant to the announcement are evaluated by the MOECCT as well.

The current regulation does not provide an appeal system for grievances regarding the quota allocation process, so any appeal against the allocated quota must go through the ordinary court system to get redress or judicial review.

Currently, the MOECCT issues quota only for HCFC-22. It is also the only controlled substance to which import license is given at present.

5.1.4. Import license and permit system

The Maldives has been implementing the licensing system for ODS since April 2002 following the Public Announcement No A-14 2002 dated 20 March 2002, which was made by the then Ministry of Trade and Industries.

Following the 2015 Act and the 2017 Regulation, an import license is being issued by the Ministry of Economic Development for the importers who have secure the quota. Under the 2015 Act and the 2017 Regulation, the licensed parties are required to get a prior permit from the MOECCT before each transaction by submitting the completed form in Annex 4 of the 2017 Regulation.

Furthermore, the import of alternatives to either banned or controlled substances under the law is subject to the same requirement of seeking a prior permit from the Ministry by submitting the form in Annex 4 of the 2017 Regulation, which can also be found on the Ministry website.¹³

Currently, only one importer, Bright Brothers, has been given the quota of 1.62 metric tonnes and the license to import HCFC-22. This is the final quota given to an importer according to the HCFC phase-out schedule.

5.1.5. Data monitoring and reporting

As explained above, the importers of HCFC, HFC, and other ODS alternatives need to fill in the form in Annex 4 of the 2017 Regulation and submit it to the MOECCT to receive their per shipment import permit. The process is now online through the Makudi System. The information that needs to be submitted includes:

- Importer's details
- Contact person's details
- Details of the substances to be imported.
 - Name of the refrigerant
 - ASHRAE number
 - Customs code
 - Country of manufacture
 - Weight content per unit

- Quantity of units to be imported
- Total weight contents to be imported

The MOECCT, together with the Ministry of Defense, has developed an online system called the *Makudi* systems to enable importers to apply for licenses and permits online.¹⁴

In addition, licensed importers are required by the 2015 Act to share statistics of their transactions every month with the MOECCT. They are required to submit the details of their monthly sales and the contact details of the client. This information is submitted via email in an excel spreadsheet; an example is attached in the annex of this report.

Furthermore, the Act requires the MOECCT to annually publish in the Government Gazette the importers which are licensed to import equipment that contains controlled substances, and the import limits determined as per the phase-down provided in the 2015 Act. However, as the ban on the import of such equipment became effective on 31 May 2016, this provision is no longer applicable. Importers of equipment are not required to have a license of any kind as the import of equipment based on controlled substance is banned by public announcement. The same procedure will apply to HFC-based equipment in the future.

Article 9 of the 2015 Act requires that the importers of substances listed under Annex 2 are required to provide data and annual statistics of transactions to the Ministry.

In addition, there is a memorandum of understanding between the NOU and the customs, and the relevant data is made available to each other upon request. Furthermore, import statistics are shared annually and kept up to date.

5.1.6. Enforcement

The 2015 Act and the 2017 Regulation provide a list of offences that are subject to penalty or fine and give the MOECCT the enforcement powers. The 2017 Regulation delegates such powers to the Maldives Customs Service. Below actions are considered an offence according to the 2015 Act and 2017 Regulation:

- to import any banned substance prescribed in the Act.
- for the permitted party to exceed the import quota for the controlled substances.
- for any persons other than the permitted party to import any controlled substance.

- to import any equipment that contains any banned or controlled substance.

The penalties for importing a banned substance is as follows.

- First-time offenders are subject to a penalty of a fine of MVR 1000 for every kg imported
- Second-time offenders are subject to a penalty of a fine of MVR 5000 for every kg imported
- Third-time and repeated offenders are subject to a penalty of a fine of MVR 8000 for every kg imported

The penalties for importing a controlled substance by a licensed party in excess to the quota limit are as follows.

- First-time offenders are subject to a penalty of a fine of MVR 1000 for every kg imported and a ban on import license for a period of 3 years
- Second-time offenders are subject to a penalty of a fine of MVR 5000 for every kg imported and a ban on import license for a period of 4 years
- Third-time and repeated offenders are subject to a penalty of a fine of MVR 8000 for every kg imported and a ban on import license for a period of 5 years

The penalties for importing a controlled substance by an unlicensed party are as follows.

- First-time offenders are subject to a penalty of a fine of MVR 1000 for every kg imported
- Second-time offenders are subject to a penalty of a fine of MVR 5000 for every kg imported
- Third-time and repeated offenders are subject to a penalty of a fine of MVR 8000 for every kg imported

The penalties for importing equipment that contains banned or controlled substances are as follows.

- First-time offenders are subject to a penalty of a fine of MVR 10,000 for each equipment imported
- Second-time offenders are subject to a penalty of a fine of MVR 50,000 for each equipment imported
- Third-time and repeated offenders are subject to a penalty of a fine of MVR 100,000 for each equipment imported

Pursuant to the 2015 Act and the 2017 Regulation, controlled substances that are imported in violation of the law and banned substances that are imported must be disposed of at a facility that uses the technology approved by the Montreal Protocol Meeting of the Parties. Where such a facility is not available, the Regulation requires the substances to be reexported. Under the Regulation, the party which imports the substances must bear the expenses of disposing or re-exporting the substances.

5.2. Policies on climate change

Although the Maldives' contribution to GHG emissions is negligible, as a low-lying Small Island Developing State (SIDS) that is very much vulnerable to the impacts of climate change, it is committed to taking a low-emissions development path.

The Maldives ratified the United Nations Framework Convention on Climate Change (UNFCCC) on 9 November 1992 and subsequently ratified the Kyoto Protocol on 30 December 1998. Further, on 22 April 2016, the Maldives ratified the Paris Agreement.

In the Maldives, there is no climate change-specific law in place. However, there are two key policy documents, namely, the Maldives Climate Change Policy Framework of 2015 and the Strategic Action Plan (SAP) 2019-2023¹⁵.

The Maldives Climate Change Policy Framework¹⁶ was published in 2015 by the MOECCT and consists of the strategic component and the building blocks. The strategic components are based on low emission development, adaptation measures, opportunities to ensure safety for food production and sustainable economic development, and meeting international obligations and commitments. The building blocks focus on technology transfer, finance, and capacity building.

SAP is a five-year action plan that sets the country's socio-economic growth targets from 2019 to 2023. It outlines the main policies and key strategies aimed at fulfilling its core pledges. It identifies the phase-down of HFC by 2045 through the actions identified under the Montreal Protocol as a specific action item.

Whilst there is no specific office for climate change in the Maldives, the MOECCT is mandated with the responsibilities related to climate change. The MOECCT is tasked with the responsibility of determining policies and practice standards related to climate change and

monitoring them, enacting regulations on climate change, providing technical assistance to relevant persons in conceptualizing projects related to climate change, advocating and representing the Maldives in international fora on climate change, developing safety measures to build resilience from effects of climate change in cooperation with international parties, coordinating projects related to climate change and providing assistance in such projects.

5.3. Policies on energy efficiency

The MOECCT is the responsible government authority for energy sector policies. The Maldives Energy Authority, established under the MOECCT, is a semi-autonomous regulatory body that operates under the guidance of a governing board convened by the President. The mandate of this authority is to establish tariffs, issue guidelines and regulations to ensure the reliability and security of the grids, and safeguard the rights and obligations of consumers and service providers.

Whilst there is no specific energy law in the Maldives, there is one policy document in place related to energy efficiency. The Maldives Energy Policy and Strategy²⁰, published in 2016 by the MOECCT outlines key energy policies and objectives of the Government. The 2016 Policy focuses on five policy goals. They are, strengthening the institutional and regulatory framework of the energy sector, promoting energy conservation and efficiency, increasing the share of renewable energy in the national energy mix, improving the reliability and sustainability of electricity service and maintaining universal access to electricity, and increasing national energy security.

The Maldives achieved universal access to electricity in 2008. The electricity generation for the greater Male region (Male, Villingili, and Hulhumale) accounts for 56.9% of the total electricity generation for all the inhabited islands. This region also has the highest annual energy consumption of approximately 400 GWh, with an installed capacity of 101 MW. The rest of the inhabited islands are equipped with 186 powerhouses. This makes up a total installed capacity of 240MW of diesel generators. The total installed capacity of renewable energy systems of the Maldives is 11MW (Island Electricity Data Book, 2018)²¹.

5.4. Policies on safety

The Measures to Protect the Ozone Layer Act 2015 and Chemical Substances and Various Equipment that Harm the Ozone Layer 2017 do not have provisions to regulate labelling, transfer, handling, servicing and storage of controlled substances. Furthermore, there is currently no legal framework in place for national harmonized standards in labelling. However, work is currently being undertaken to develop a national code on classification and labelling.

The Maldives currently imports only HCFC-22 and R-404A, R-407C, R-410A, R-417A, R-507C and R-438A blends of HFC. While there are no specific legal requirements in place for the safe handling of the aforesaid substances, there is a general regulation called Hazardous Chemical Regulation (Regulation Number: R-1057/2019)²⁴, which is enacted under Import Prohibition Act (Law Number: 4/75). This regulation is monitored and implemented by the Ministry of Defense. This regulation categorizes dangerous chemicals based on the International Maritime on Dangerous Goods Code (IMDG Code). As some of the

aforementioned substances, especially HCFC-22, fall within class 2 of the IMDG Code, the following rules apply:

- All imports must bear the respective color code provided in the regulation, "Caution!", "Hazardous Chemical" and "Danger" labels even at the time of import, during handling, transfer, storage, and sale.
- Special requirements on handling and transfer, including standards in accordance with IMDG code on handling substances.
- Special requirements on storage and warehouses, including standards in accordance with IMDG code on storage of substances. These requirements include standards on ventilation, cooling spaces, heat mitigation, and safety.

5.5. Policies on chemical and waste management

As identified in the Maldives National Chemical Profile²⁵ published in 2015 by the MOECCT, despite there being many laws that address chemical and waste management in part as shown in the table below, there is no national legislation focusing specifically on chemical management. Furthermore, as highlighted in that study, as the Maldives does not manufacture and chemicals and imports all chemicals, most of these laws concentrate on imports. Additionally, the study finds that there is no control on the quality of the chemicals and labelling at present, except for the labelling according to the Dangerous Chemicals Regulation. The study further finds that there is no comprehensive reporting mechanism in place for consumers, distributors, and retailers. The same finding is made concerning the lack of a comprehensive mechanism for licensing distributors, users, and retailers of chemicals, save for chemicals used for pharmaceutical purposes. In addition, there is no prescriptive list of hazardous waste which includes ODS or HFC.

5.6. Other relevant policies

The Maldives legal system has adopted fiscal measures to encourage environment-friendly refrigerants by providing import duty incentives. The 17th Amendment of Law no 31/79 of the Import-Export Act 1979 of Maldives, chapter 29 on organic chemicals, states that HC-600a is subject to 5% import tax while HFCs (R-142B, R-141B, R-123, R-33) is subject to 100% import duty. Furthermore, chapter 33 on products or equipment containing certain HFC blends (R-502, R-402B, R-408A, R-406A) is subject to 100% import duty.

In the building and construction sector, whilst the Maldives has newly adopted a Building Code³⁰ under the 2017 Construction Act, there are no specific rules in the said laws on space cooling or the promotion of low GWP options.

Concerning air quality, in 2019, the MOECCT published the National Action Plan on Air Pollutants³¹, a comprehensive policy document that outlines the mitigation measures to reduce emissions, measures to reduce air pollutants, and measures to enhance implementation, monitoring, and management of air quality. This Action Plan outlines key action items specifically targeted towards implementing the Kigali Amendment and focused on sensitizing both the tourism and the fisheries sectors on the HFC phase-down.

6. STAKEHOLDER ENGAGEMENT

This chapter discusses the key stakeholders that play a role in the implementation of the Montreal Protocol in the Maldives and the main platforms and activities that are in place or are being undertaken to engage the stakeholders and coordinate their work. The NOU is the focal point for the Montreal Protocol and all collaborations with stakeholders are done through the NOU.

The stakeholders identified in the next section are the key players in the implementation of the Montreal Protocol. They have been identified based on their role in policymaking and the market and influence in the process of implementation.

6.1. Stakeholder Mapping

The table below provides a list of stakeholders which include national authorities, and educational institutes in the Maldives that currently play a role in the control of ODS and equipment containing them. There is no official document that identifies all stakeholders and defines their roles. The stakeholders and their roles have been identified based on the nature of the entity's mandate and based on what has been practiced so far.

6.2. National Ozone Unit

The National Ozone Unit (NOU) became fully operational only in 2000 when it was set up at the Environment Research Centre (ERC). In 2009, the functions and the name of ERC were changed to Environmental Protection Agency (EPA), and the NOU was moved to be under then the Ministry of Housing, Transport, and Environment, and has remained as a Unit within the Ministry since.

7. ASSESSMENT OF NEEDS FOR HFC PHASE-DOWN IN THE MALDIVES

This chapter assesses the gaps between the need for the Maldives to implement the Kigali Amendment and the current established national infrastructure in different aspects elaborated in the previous chapters of the report. It also provides necessary actions and options to fill these identified gaps, especially the actions needed for the country to meet its initial obligations under the Kigali Amendment.

7.1. Gaps and needs in the market

Recommended Actions	Description
Develop an early plan to support the small businesses that will be affected by the HFC phase-down	Phasing down HFCs will have a significant impact on small businesses across the country. To minimize the negative impact, it is important to actively involve all stakeholders and develop a phase-down plan that will ease their transition. The plan should provide opportunities for any capacity-building training that is needed as well. The plan can be officially registered through an MOU between the MOECCT and the relevant business. The early development of such a phase- down plan will prepare the businesses and provide adequate time to ensure country targets are attained in advance.
Develop financial incentive schemes to support businesses to retrofit and replace high GWP based RAC equipment	Complying with the Kigali Amendment means replacing RAC equipment that uses high GWP refrigerants. This will no doubt be costly for businesses. 7.2. Gaps and needs in the RAC servicing sector

There is a major policy gap to regulate the RAC servicing sector in the Maldives in terms of eligibility to work as a technician and standards of practice. Below actions are required to improve the capacity and the control of the servicing sector.

Recommended Actions	Description
Amend the 2015 Act to empower the MOE to regulate the servicing sector	Include a provision in the 2015 Act that empowers the MOE to regulate the servicing sector workshops and technicians. This will provide a legal basis for the MOE to act.
Enact a regulation to regulate the servicing sector	The regulation should include provisions on the standards of operation, codes of practice, technical guidelines, data management of servicing sector, and the licensing requirements of the technicians.
Introduce the RAC servicing technicians licensing system	The RAC servicing sector in the Maldives is unregulated and mainly comprised of semi-skilled workers who are predominantly expatriates. Although a portion of the RAC workforce includes trained professionals, it is generally challenging to implement good practices in RAC equipment servicing. This also often compromises the lifespan of the equipment. A properly structured licensing system for RAC technicians will help ensure that the technicians are up to date with the latest knowledge, skills, and technologies and enable the wider application of good servicing practices in the sector. It can be implemented voluntarily and be made mandatory within five years. A database of licensed technicians should be established as well.

8. CONCLUSION AND SUMMARY OF RECOMMENDED ACTIONS

In this report, the status of the implementation of the Montreal Protocol in the Maldives and its readiness to adopt its new amendment to phase down HFCs was reviewed. Based on the current market trends and the policy framework, the following conclusion can be drawn.

Maldives's ratification and implementation of the Kigali Amendment will contribute to the international effort to contribute to the mitigation of climate change. Furthermore, it contributes to regulating the servicing sector which will play a key role in supporting low emissions development.

The Maldives has successfully phased out HCFCs and is ready to create an enabling environment to safely transition to greener alternatives and contribute towards the country's energy efficiency goals as well.

Regarding the country's readiness, many areas need to be improved to create an enabling environment to implement the Kigali Amendment as discussed in the previous chapter. The list of recommended actions is summarized in the table below.
