Instructions to the Assessor on Competency Based Assessment (CBA)

Assessment is the process of identifying a participant's current knowledge, skills and attitudes sets against all elements of competency within a unit of competency.

Suggested Assessment Methods

For each unit of competency, a number of assessment tools have been identified including:

- ✓ Work Projects
- ✓ Oral Questions
- ✓ Written Questions
- ✓ Third Party Statements
- ✓ Observation Checklists.

Instructions and Evidence Recording Sheets have been identified in this Assessment Manual for use by Assessors.

Alternative Assessment Methods

Whilst the above-mentioned assessment methods are suggested assessment methods, the assessor may use an alternate method of assessment taking into account:

- a. The nature of the unit
- b. The strengths of participants
- c. The number of participants in the class
- d. Time required to complete assessments
- e. Time dedicated to assessment
- f. Equipment and resources required.

Alternate assessment methods include:

- ✓ Practical demonstrations
- ✓ Practical demonstrations in simulated work conditions Problem solving
- ✓ Portfolios of evidence
- ✓ Critical incident reports
- ✓ Journals
- ✓ Oral presentations
- ✓ Interviews
- ✓ Videos
- ✓ Visuals/slides/audio tapes
- ✓ Case studies
- ✓ Log books
- ✓ Projects and Role plays
- ✓ Group projects
- ✓ Recognition of Prior Learning.

Whilst there is no specific instruction or evidence collection documents for all the alternative assessment methods, assessors can record competency in the "Other" section within the "Competency Recording Sheet".

Selection of Assessment Methods

Each assessor will determine the combination of Assessment Methods to be used to determine Competency for each Competency Unit on a student by student basis.

"Sufficient" evidence to support the "Competent"/"Not Yet Competent" decision must be captured.

In practice this means a minimum of two - three Assessment Methods for each candidate for each Competency Element is suggested.

At least one method should provide evidence of practical demonstration of competence.

The following assessment methods deemed to provide evidence of practical demonstration of competence include:

- ✓ Practical Work Projects
- ✓ Third Party Statement
- ✓ Observation Checklist.

Assessing Competency

Competency based assessment does not award grades, but simply identifies if the participant has the knowledge, skills and attitudes to undertake the required task to the specified standard.

Therefore, when assessing competency, an assessor has two possible results that can be awarded:

- ✓ "Competent" (C)
- ✓ "Not Yet Competent (NYC)

Competent (C)

If the participant is able to successfully answer or demonstrate what is required, to the expected standards of the performance criteria, they will be deemed as "Competent" (C).

The assessor will award a "Competent" (C) if they feel the participant has the necessary knowledge, skills and attitudes in all assessment tasks for a unit.

Not Yet Competent' (NYC)

If the participant is unable to answer or demonstrate competency to the desired standard, they will be deemed to be "Not Yet Competent" (NYC).

This does not mean the participant will need to complete all the assessment tasks again. The focus will be on the specific assessment tasks that were not performed to the expected standards.

The participant may be required to:

- a. Undertake further training or instruction
- b. Undertake the assessment task again until they are deemed to be "Competent".

Trade Testing (Recognition of Prior Learning)

Trade Testing or Recognition of Prior Learning is the process that gives current industry professionals who do not have a formal qualification, the opportunity to benchmark their extensive skills and experience against the standards set out in each unit of competency/subject.

This process is a learning and assessment pathway which encompasses:

- ✓ Recognition of Current Competencies (RCC)
- ✓ Skills auditing
- ✓ Gap analysis and training
- ✓ Credit transfer.

Code of practice for assessors

This Code of Practice provides:

- ✓ Assessors with direction on the standard of practice expected of them
- ✓ Candidates with assurance of the standards of practice expected of assessors
- ✓ Employers with assurance of the standards maintained in the conduct of assessment.

The Code detailed below is based on the available international code of ethics and practice.

- ✓ The differing needs and requirements of the person being assessed, the local enterprise and/or industry are identified and handled with sensitivity
- ✓ Potential forms of conflict of interest in the assessment process and/or outcomes are identified and appropriate referrals are made, if necessary
- ✓ All forms of harassment are avoided throughout the planning, conducting, reviewing and reporting of the assessment outcomes
- ✓ The rights of the candidate are protected during and after the assessment
- ✓ Personal and interpersonal factors that are not relevant to the assessment of competency must not influence the assessment outcomes
- ✓ The candidate is made aware of rights and process of appeal
- ✓ Evidence that is gathered during the assessment is verified for validity, reliability, authenticity, sufficiency and currency
- ✓ Assessment decisions are based on available evidence that can be produced and verified by another assessor
- ✓ Assessments are conducted within the boundaries of the assessment system policies and procedures
- ✓ Formal agreement is obtained from both the candidate and the assessor that the assessment was carried out in accordance with agreed procedures
- ✓ The candidate is informed of all assessment reporting processes prior to the assessment
- ✓ The candidate is informed of all known potential consequences of decisions arising from an assessment, prior to the assessment
- ✓ Confidentiality is maintained regarding assessment results
- ✓ The assessment results are used consistently with the purposes explained to the candidate
- ✓ Opportunities are created for technical assistance in planning, conducting and reviewing assessment procedures and outcomes.

Instructions and checklist for assessors

Instructions

General instructions for the assessment

- ✓ Assessment should be conducted at a scheduled time that has been notified to the candidate
- ✓ Facilitators must ensure participants are made aware of the need to complete assessments and attend assessment sessions
- ✓ If a participant is unable to attend a scheduled session, they must make arrangements with the Assessor to undertake the assessment at an alternative time
- ✓ At the end of the assessment the Assessor must give feedback and advise the participant on their C/NYC status
- ✓ Complete the relevant documentation and submit to the appropriate department.

Preparation

- ✓ Gain familiarity with the Unit of Competency, Elements of Competency and the Performance Criteria expected
- ✓ Study details assessment documentation and requirements
- ✓ Brief candidate regarding all assessment criteria and requirements.

Briefing Checklist

✓ Begin the assessment by implementing the following checklist and then invite the candidate to proceed with assessment.

Instructions for recording competency

Specifications for Recording Competency

The following specifications apply to the preparation of Evidence Gathering Plans:

- ✓ A Competency Recording Sheet must be prepared for each candidate to ensure and demonstrate all Performance Criteria and Competency Elements are appropriately assessed. This Sheet indicates how the Assessor will gather evidence during their assessment of each candidate
- ✓ This Competency Recording Sheet is located at the end of the Assessment Plan It is the overriding document to record competency
- ✓ Assessor may vary the Competency Recording Sheet to accommodate practical and individual candidate and/or workplace needs
- ✓ Assessor must place a tick (②) in the "Assessment Method" columns to identify the methods of assessment to be used for each candidate
- ✓ Multiple Competency Elements/Performance Criteria may be assessed at the one time, where appropriate

- ✓ The assessor and participant should sign and date the Competency Recording Sheet, when all forms of evidence and assessment have been completed
- ✓ The assessor may provide and feedback or clarify questions which the participant may have in regards to the assessment grade or findings
- ✓ All documents used to capture evidence must be retained, and attached to the Competency Recording Sheet for each candidate for each Competency Unit.

Instructions for different assessment methods

Specifications for Work Project Assessment

These guidelines concern the use of work projects.

The work projects identified in the Training Manuals involve a range of tasks, to be performed at the discretion of the Assessor.

Work project tasks can be completed through any form of assessment as identified in the Trainer and Trainee Manuals and stated at the start of this section.

Assessors should follow these guidelines:

- ✓ Review the Work Projects at the end of each "Element of Competency" in the Trainee Manual to ensure you understand the content and what is expected
- ✓ Prepare sufficient resources for the completion of work activities including:
 - Time whether in scheduled delivery hours or suggested time participants to spend outside of class hours
 - Resources this may involve technical equipment, computer, internet access, stationery and other supplementary materials and documents
- ✓ Prepare assessment location (if done in class) making it conducive to assessment
- ✓ Explain Work Projects assessment to candidate, at the start of each Element of Competency. This ensures that participants are aware of what is expected and can collate information as delivery takes place.
- ✓ Assessors can use the following phrase as a guide (where an "X" is identified, please input appropriate information):

"At the end of each Element of Competency there are Work Projects which must be completed. These projects require different tasks that must be completed. These work projects are part of the formal assessment for the unit of competency titled X.

- You are required to complete these activities:
 - Using the 'X' method of assessment.
 - At 'X' location
 - You will have 'X time period' for this assessment.
- You are required to compile information in a format that you feel is appropriate to the assessment.
- Do you have any questions about this assessment?"
- ✓ Commence Work Project assessment:
- ✓ The assessor may give time for participants to review the questions at this time to ensure they understand the nature of the questions. The assessor may need to clarify questions.
- ✓ Participants complete work projects in the most appropriate format

- ✓ Participants must submit Work Project evidence to the assessor before the scheduled due date
- ✓ Assessor must assess the participant's evidence against the competency standards specified in each Element of Competency and their own understanding. The assessor can determine if the participant has provided evidence to a "competent" standard.
- ✓ Transcribe results/details to Competency Recording Sheet
- ✓ Forward/file assessment record.

Specifications for Oral Question Assessment

These guidelines concern the use of oral questioning. Assessors should follow these guidelines.

- ✓ Prepare Assessment Record for Oral Questioning. One record for each candidate:
 - Enter Student name
 - Enter Assessor name
 - Enter Location
- ✓ Familiarize self with Questions to be asked
- ✓ Prepare assessment location (table and chairs) making it conducive to assessment
- ✓ Explain Oral Questioning assessment to candidate, using the following phrase as a guide (where a "X" is identified, please input appropriate information):

"These oral questions are part of the formal assessment for the unit of competency titled X.

There are X questions and you are required to answer all of them to the best of your ability and I will record whether or not you have answered correctly.

- I will give you feedback at the end of the assessment.
- Do you have any questions about this assessment?"
- ✓ Commence Oral Questioning assessment
- ✓ Complete Assessment Record for the Oral Questioning by:
 - Ticking C or NYC, as appropriate
 - Entering "Remarks" as required
 - Completing Oral Questioning within 60 minutes
- ✓ Complete Oral Questioning and provide feedback to candidate
- ✓ Transcribe results/details to Competency Recording Sheet
- ✓ Forward/file assessment record.

Specifications for Written Question Assessment

These guidelines concern the use of written questioning. Assessors should follow these guidelines.

- ✓ Familiarize self with Ouestions and Answers provided.
- ✓ Print and distribute copies of "Written Questions" for participants. Ideally this should take place with adequate time for participants to answer all questions before the expected due date.
- ✓ Explain Written Questioning assessment to candidate, using the following phrase as a guide (where a "X" is identified, please input appropriate information):

"These written questions are part of the formal assessment for the unit of competency titled X.

There are X questions and you are required to answer all of them to the best of your ability.

You may refer to your subject materials, however where possible try to utilise your existing knowledge when answering questions.

Where you are unsure of questions, please ask the Assessor for further instruction. This may be answering the question orally or asking the assessor to redefine the question. We have X time for this assessment.

- The due date for completion of this assessment is X
- On this date you must forward the completed questions to the assessor by X time on the date of X
- Do you have any questions about this assessment?"
- ✓ The assessor may give time for participants to review the questions at this time to ensure they understand the nature of the questions. The assessor may need to clarify questions. Participants may record written answers (where possible)
- ✓ Participants must submit the written answers to the assessor before the scheduled due
- ✓ Assessor must assess the participant's written answers against the model answers provided as a guide, or their own understanding. The assessor can determine if the participant has answered the questions to a "competent" standard.
- ✓ Transcribe results/details to Competency Recording Sheet
- ✓ Forward/file assessment record.

Specifications for Observation Checklist

These specifications apply to the use of the Observation Checklist in determining competency for candidates.

Only an approved assessor is authorized to complete the Observation Checklist.

The assessor is required to observe the participant, ideally in a simulated environment or their practical workplace setting and record their performance (or otherwise) of the competencies listed on the Observation Checklist for the Competency Unit.

To complete the Observation Checklist the Assessor must:

- ✓ Insert name of candidate ✓ Insert assessor name
- ✓ Insert identify of location where observations are being undertaken
- ✓ Insert date/s of observations may be single date or multiple dates
- ✓ Place a tick in either the "Yes" or "No" box \bar{f} or each listed Performance Criteria to indicate the candidate has demonstrated/not demonstrated that skill
- ✓ Provide written (and verbal) feedback to candidate as/if appropriate Sign and date the
- ✓ Present form to candidate for them to sign and date
- ✓ Transcribe results/details to Competency Recording Sheet for candidate
- ✓ Forward/file Observation Checklist.

This source of evidence combines with other forms of assessment to assist in determining the "Competent" or "Not Yet Competent" decision for the participant.

Specifications for Third Party Statement

These specifications relate to the use of a relevant workplace person to assist in determining competency for candidates.

The Third-Party Statement is to be supplied by the assessor to a person in the workplace who supervises and/or works closely with the participant.

This may be their Supervisor, the venue manager, the Department Manager or similar.

The Third-Party Statement asks the Supervisor to record what they believe to be the competencies of the participant based on their workplace experience of the participant. This experience may be gained through observation of their workplace performance, feedback from others, inspection of candidate's work etc.

A meeting must take place between the Assessor and the Third Party to explain and demonstrate the use of the Third-Party Statement.

To complete the Third-Party Verification Statement the Assessor must:

- ✓ Insert candidate name
- ✓ Insert name and contact details of the Third Party
- ✓ Tick the box to indicate the relationship of the Third Party to the candidate
- ✓ Present the partially completed form to the Third Party for them to finalize
- ✓ Collect the completed form from the Third Party
- ✓ Transcribe results/details to Competency Recording Sheet for candidate Forward/file Third Party Statement.

The Third Party must:

- 1. Record their belief regarding candidate ability/competency as either:
 - Competent = Yes
 - Not Yet Competent = No
 - Unsure about whether candidate is competent or not = Not Sure
- 2. Meet briefly with the assessor to discuss and/or clarify the form.

This source of evidence combines with other forms of assessment to assist in determining the "Competent" or "Not Yet Competent" decision for the candidate.

A separate Third-Party Statement is required for each Competency Unit undertaken by the candidate.

Measure up and mix a small quantity of Metalgrade Express and apply it along the edge of the hole. Remember to squeeze the product hard into the surface to secure good bonding. If needed secure it with additional polymer. ✓ Allow drying for 6 minutes (at 20°C). With the mesh securely fastened measure up and mix a sufficient quantity of Metalgrade Rebuild. Apply the product to totally encapsulate the mesh and blend it in with the Metalgrade Express already on the cast-iron edge. ✓ If the mesh size is too big, and the polymer falls through, apply reinforcement bandage on the mesh to prevent it happening. ✓ If necessary, support the mesh by placing steel wires across the hole. The wires can be fastened to the edge by a small tack weld or by drilling a hole with slightly bigger diameter.

Do not breathe the fumes. ✓ Ventilate the work area and/or use local forced ventilation at the arc to remove welding fumes and gases. The recommended way to determine adequate ventilation is to sample for the composition and quantity of fumes and gases to which personnel are exposed. ✓ If ventilation is poor, wear an approved air-supplied respirator. ✓ Do not weld on coated metals, such as galvanized, lead, or cadmium plated steel, unless the coating is removed from the weld area, the area is well ventilated, and while wearing an air-supplied respirator. The coatings and any metals containing these elements can give off toxic fumes if welded. ✓ Read and understand the Safety Data Sheets (SDSs) and the manufacturer's instructions for adhesives, coatings, cleaners, consumables, coolants, degreasers, fluxes, and metals. ✓ Work in a confined space only if it is well ventilated, or while wearing an air- supplied respirator. 6	What is centrifugal?	Centrifugal pumps use a set of rapidly spinning impellor blades. As these impellor blades spin around an axis, centrifugal force causes the water to travel along the surface of the blades to the outer rim of the impellor assembly. Water enters the impellor unit through a port in the axis, and in effect, the spinning blades fling the water outward. The force imparted by the rotation forces the water out of the impellor casing via a discharge port built into the pump's outer housing.
7	What is positive displacement pump?	Positive displacement pumps "push" instead of "fling." They utilize a reciprocating mechanical device, such as a piston inside of a cylinder, which pushes water out of a chamber and propels it out through the discharge pipelines. Other types of reciprocating mechanisms include bellow cavity, vibrating diaphragm, or drumhead squeezing a peristaltic with a pair of pinch rollers and syringes. This last type differs from pistons in that they operated at low flow rates but high-pressure heads.
8	What is the first step of proper maintenance?	Proper maintenance is setting up the pumping operations to prevent damage in the first place.
9	What is cavitation?	Cavitation is defined as "the formation of bubbles or cavities in liquid, developed in areas of relatively low pressure around an impeller.
10	How does cavitation occur?	Cavitation can occur at either the suction or discharge end of the pump. Suction cavitation results when the pump is left to operate in a low-pressure regime (caused by poor pipe system design, not meeting the pump's NPSHr standards, or partial or complete blockage of the intake and its filters) resulting in the pump not receiving enough water inflow.
11	What are active measures that can be taken to minimize the potential for cavitation?	First and foremost, the filters and strainers at the pump's intake should be checked and cleaned on a regular basis. Clogging of any kind can create the pressure imbalances that lead to cavitation. In many cases heavy filtration including mounds of filter stones and layers of geotextile are required in the field to prevent suspended solids from entering the pump. The pump's operation should be monitored to ensure that it is working within the acceptable zone and preferably at the pump's best efficiency point. Conversely, the piping system receiving discharge from the pump can be modified to eliminate the pressure differential that can lead to cavitation.
12	What is ice formation?	Ice formation, which can be considered to be a special type of floating debris. Ice clogging, either partial or complete plugging, can damage a pump during operation by preventing discharge and causing cavitation to reduced discharge flow rates.
13	What are routine inspections?	Routine inspections (weekly to monthly) should examine oil level and condition, noise and vibration, bearing temperatures, leaks from the pump housing, leaks from pipe connections, cracks in pipes or hoses, discharge pressure, intake pressure, seal integrity, and operating temperature.
14	What does quarterly inspections consist of?	Quarterly inspections include checking the mechanical seals, changing the oil, and shaft alignment.

5	What is self-recording type of rain gauge?	Self-recording type rain gauges automatically record on a daily basis a continuous plot of rainfall depth against time down to 15 minutes interval or even less, whereas, non-recording rain gauges can only record cumulative rainfall for a day that is measured daily at site.
6	Describe use of non-recording gauges.	The data collected using non-recording gauges are of limited use for design purpose. Hence, non-recording gauges are being gradually replaced in Indian subcontinent.
7	What is weighing bucket type rain gauge?	Weighing bucket type rain gauge is most common self-recording rain gauge. It consists of a receiver bucket supported by a spring or lever balance or some other weighing mechanism.
8	What is floating or natural syphon type rain gauge?	The working of this type of rain gauge is similar to weighing bucket rain gauge. A funnel receives the water which is collected in a rectangular container. A float is provided at the bottom of container, and this float rises as the water level rises in the container. Its movement is recorded by a pen moving on a recording drum actuated by a clock work.
9	Describe briefly about rainfall analysis. Give an example as well.	Rainfall analysis is carried out to identify and sort out various magnitudes (intensities) of rainfall events and their corresponding durations occurring at a station from a continuous series of historic rainfall records taken for a fairly long period viz. last 25 - 30 years or more. IDF curves are not static as they are influenced by change in pattern of rainfall and therefore IDF curve should be prepared at an interval of 5 – 10 years for accurate results. The rainfall analysis helps to establish intensity-duration-frequency relationship for various frequencies which are used in estimation of runoff for design of storm water drains. The frequency or return period of a storm event may be defined as the average recurrence interval between events equal to and exceeding a specified magnitude. For example, if it is stated that a return period of a rainfall of magnitude 70 mm/hour at a station is 10 years that implies that on an average rainfall magnitude equals or exceeds 70 mm/hr once in 10 years.
10	What should be prevented while working with trench boxes?	When working with trench boxes, it is critical to prevent disruption of the pipe installation while moving the trench box. If the trench box cannot be dragged without disrupting the pipe or initial backfill, it must be lifted in sections.
11	What are the several methods of improving the foundation prior to installation depending on the soil condition?	Reinforce – Soft soils are reinforced by adding dry soil, stabilizing geotextile or geogrid materials, or lime and then compacting for stabilization. Displace – Soupy soils are displaced by placing an overburden material such as large aggregate in the bottom until the foundation is consolidated and stabilized. Restore – Loose soils can be restored by compacting to a greater density. Remove – Existing soils that are unusable should be completely excavated and replaced with a suitable material.
12	Explain about unyielding.	Unyielding materials, such as rock, in the trench bottom also pose a potential problem. To protect the pipe, bedding depth should be increased to 6"-10" as directed by a geotechnical engineer. Over-excavation of the trench may be required to

		accommodate the increased bedding while still achieving the desired line and grade.
13	Explain about bedding.	The bedding material is placed in the bottom of the trench, between the foundation and the bottom of the pipe. The bedding allows for uniform longitudinal support and also distributes the load from the bottom of the pipe. The minimum bedding thickness should be a minimum of four inches for 4"-36" diameter pipe and a minimum of six inches for 42"-60" diameter pipe.
14	What the following factors to check prior laying pipe?	Before pipe is laid into the trench, re-inspect the pipe for any damage and clean any debris that may have accumulated on the inside of the pipe or sealing surfaces. Pipe should also be checked to ensure that it is the correct type and size. The pipe should be lowered into the trench using slings placed in a manner that evenly supports the pipe. It is good practice to use a "tag line" when moving the pipe into position; this is a line attached to the end of the pipe, used to prevent uncontrolled pipe movement.
15	What are the two way that can push the pipe together?	Smaller diameter pipe may be pushed together by hand or leveraged together using a spanner block and a lever
16	Explain backfilling process.	The backfilling process is critical to ensure long trouble free service. The backfill and pipe function together as a structural system, forming the pipe/soil envelope, to support the soil overburden and live vehicular loads. For this reason, the backfill material and level of compaction directly impacts the performance of the pipe/soil envelope. The backfill material must have a high density as well as a resistance to migration and degradation.
17	What is deflection testing?	Deflection testing is generally not required when using proper construction practices associated with initial backfill material selection, placement and compaction. However, if considered necessary, random deflection tests of pipe may be performed within 30 days of installation.
18	What is geotextiles?	To prevent the migration of fine soil particles into the pipe/soil envelope, the use of a geotextile may need to be considered. When the groundwater table is at or above the elevation of the pipe, fine particles from the in-situ soil have a tendency to migrate into the course backfill which can result in a loss of pipe support. The geotextile will act as a filter around the bedding, haunch and initial backfill and prevent this migration from occurring. Due to the wide variety of soil and site conditions, the use of a geotextile should be determined by a geotechnical engineer.
