Project Assistant (individual) for "Project Implementation Unit under National Ozone Unit

The Ministry of Environment, Climate Change and Technology has received funding from the Multilateral Fund (MLF) for the Implementation of the Montreal Protocol on Substances that depelete the Ozone Layer towards Institutional Strengthening of the National Ozone Unit, and intends to apply part of the proceeds to recruit a Project Assistant who will be responsible to ensure that the projects under the National Ozone Unit are completed within the timeline and budgetary restrictions.

The Ministry of Environment, Climate Change and Technology invites interested eligible individual consultants to submit their application.

Schedule for the Assignment
