Specific data categories will be finalized during the needs assessment phase in consultation with stakeholders.
2.	NA	NA	It is mentioned that interfaces for data capturing need to be developed without clear specifications for the data . Could you clarify the expected scope and functionality of these interfaces?	The interfaces should allow stakeholders to securely submit data in various formats, including direct data entry, Excel or CSV uploads, and API-based extraction. These interfaces will also feature user authentication, data validation mechanisms, and notification features for submissions
3.	NA	NA	Is the integration methodology for all institutions expected to follow a homogeneous approach, or will there be varying integration mechanisms depending on the institution?	Integration mechanisms may vary based on the institution's data systems and capacities. The system should support API-based integration and manual data uploads to ensure flexibility and adaptability
