The Ministry of Tourism and Environment has received funding from the Global Environment Facility (GEF) towards implementing the project “Implementing Sustainable Low and non-Chemical Development in SIDS (ISLANDS)”, and intends to apply part of the proceeds to recruit a Communication Coordinator who will be responsible to support the Project Management Unit (PMU) to ensure the project is completed within timeline and budgetary restrictions.
