1. EXECUTIVE SUMMARY

The outer islands of the Maldives experiences drinking water shortages during the dry season. The Government of the Maldives, with the support of the UNDP received financing from the Green Climate Fund (GCF) to undertake the "Supporting Vulnerable Communities in Maldives to Manage Climate Change-Induced Water Shortages" Project. The project will support in reviewing existing procedures, documents, guidelines and regulations on water management and distribution. Carry out surveys and collect data. Based on attained information develop a Potable Water Security Operation Plan.

Potable Water Security Operation Plan proposes three types of strategies and systems to ensure safe and secure potable water to people in the islands of Maldives. Following are the recommended strategies;

- 1. Continuous Strategies
 - a. Develop and implement a rainfall alert system
 - b. Measurement of Potable Water levels
 - c. Education and Awareness Campaigns
- 2. Short Term Strategies (to be implemented within 1 to 3 years)
 - a. Increasing Community Water Reserve by increasing Catchment Areas
 - b. Increasing Participation of the Private Sector in Water Supply Services
 - c. Increasing Participation of Community Groups in Water Management Services
 - d. Packaging Filtered Potable Water
- 3. Long Term Strategy (to be implemented with 5 years) is development of a water network

In the situation where potable water runs out during dry season three types of emergency water supply systems are proposed. They are;

- 1. Decentralized Water Supply System: supplying water in containers via decentralized hubs
- 2. Supplying Bottled Potable Water: supplying packaged filtered water bottles via decentralized hubs
- 3. Portable RO Plant: producing water onsite (recommended option)

To ensure the quality of water supplied to the public, all parties responsible in implementing the Potable Water Security Plan especially Emergency Water Supply Systems should comply with the guideline and standard set by EPA and MFDA respectively. It is recommended to distribute Water quality kits to islands and also be readily available to buy at pharmacies for individual use.

Staff from island hospitals and health centers to be trained to conduct water quality checks via water quality kits.

The main stakeholders of effective implementation of this plan are Ministry of Environment, Island Councils, Utility Providers, Maldives National Defense Force, Maldives Food and Drug Authority, Environment Protection Agency, Maldives Food and Drug Authority and Maldives Meteorological Service.

2. INTRODUCTION

The outer islands of the Maldives experiences drinking water shortages during the dry season. The Government of the Maldives, with the support of the UNDP received financing from the Green Climate Fund (GCF) to undertake the "Supporting Vulnerable Communities in Maldives to Manage Climate Change-Induced Water Shortages" Project. This project will introduce decentralized and cost-effective dry season water supply systems, in which the proposed solution is to create additional, atoll level water hubs to improve timeliness and efficiency of water delivery during the periods of water shortages. Aim of the project is to deliver safe and secure freshwater to people in the islands of Maldives.

The project will support in reviewing existing procedures, documents, guidelines and regulations on water management and distribution. Carry out surveys and collect data. Based on attained information develop a Potable Water Security Operation Plan for effective execution.

2.1. Scope and Purpose

This report aims to achieve the following deliverables of the project:

- Undertake a desk review of existing procedures and material on water production, water storage and demand in the islands; the existing dry-season water distribution operation; and the review of existing monitoring coordination mechanisms (including online portal) and regulatory and legal frameworks
- 2. Determination of the necessary operational arrangements/institutional arrangements, roles and responsibilities that ensure for organized and coordinated actions;
- 3. Appraise the existing decentralized, sub-national water production and distribution hubs (both in the North and South of Maldives) and create/determine the distribution hubs;
- 4. Determine a decentralized early warning strategy (to be further developed with the online portal) for water emergency alerts which is based on forecasted meteorological information and crowd-sourcing develop a framework for early warning system
- 5. Ensure adequate consultation and feedback from all national and island-level stakeholders (especially Women's Development Committees (WDC), island councils and other community groups) in the process of identifying gaps and issues in current operations and in the consolidation of the Potable Water Security Operation Plan;
- Consolidation and finalization of the Potable Water Security Operation Plan including the year-round Potable Water Management Operations and; the dry-season Water Distribution Operations

3. BACKGROUND

Since the conception of the project, many advancements have been made in the dry-season season response operations. As a consequence, the timeliness and effectiveness of water distribution and management is believed to have improved dramatically from the initial project baseline records.

Currently the Water and Sanitation Department (WATSAN Dept.) in the Ministry liaises with the utility company to supply potable water to the affected islands during the dry-period. There is a written Dry-season Procedure (please find attached under annexure A) guiding the water distribution process and a contractual agreement between WATSAN Dept. and the utility to enable execution of water distribution.

Once an island is in shortage of potable water, the island council lodges an application, via a standard water request form, to the utility services provider on the island requesting for potable water. If there is no local office for the utility provider on the island, the water request form will be sent to the utility head office.

Utility service provider assesses the applications from the island councils and operationalizes the transfer of potable water from the closest possible island(s) with sufficient water production capacity such as R/O facilities. HDPE tanks are filled with potable water and transported on sea-going vessels. Water Quality tests are conducted before transportation and after delivery to the beneficiary island. The water quality tests are required to comply with the MFDA regulations (please find attached under annexure B). Once the operation is completed, it will be verified and checked via a delivery receipt for record.

The Ministry plays a monitoring role, and keeps track of the operations and maintains records of the water shortage requests and the distribution of water. The already existing procedures are based on reduction of cost and time and long term sustainability of the operation. These operations also adhere to the points of reference set in the legal frameworks that has been developed.

In addition to the above mentioned government has been developing water networks and rain water harvesting systems through Public Sector Investment Projects (PSIP) via government budget, grants and funds. The current government target to develop water networks in all inhabited islands in the next 5 years. Following is a summary table of a water related projects.

4. RESEARCH FRAMEWORK

The following diagram summarizes the work carried out to arrive at a potable water security plan. Research methodology to achieve the main deliverables have been identified and presented during inception stage.

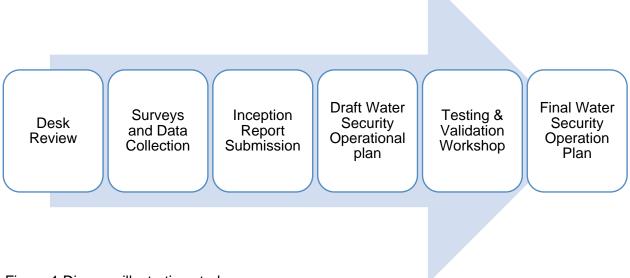


Figure 1 Diagram illustrating study process

4.1. Desk Review

A desk review on existing documents on water management in Maldives was conducted. The documents were provided by Ministry of Environment, National bureau of statistics (NBS), National Disaster Management Center (NDMC) and utility. The documents include written reports, population tables and generated maps. The Socio-economic reports (STC,DTM.2017) helped conclude the following points;

- 1. Public is satisfied with household rainwater
- 2. Islands have high demand to increase rainwater harvest
- 3. Majority of the people buy bottled drinking water
- 4. 40 to 50% people use public tanks in case of water shortage in some cases shortage and high demand for public water system
- 5. Average household storage capacity 2500 to 3500ltrs
- 6. More than 50% of people are willing to pay for better quality water

It was deemed most appropriate to build on this study by leading with a qualitative research approach. The next step taken was to identify islands facing potable water shortages. Dry report data (ME.2005 - 2017 ME) and Emergency Water Supply Report (NDMC.2016-2017) had listed the islands requesting water starting from year 2005.

To understand how the highlighted islands were spread out geographically and for the purpose of visualization the data was layered into tables and maps. Haa Alif, Haa Dhaal, Shaviyani and Noonu were identified atolls consisting of the most number of islands requesting for water (please refer to the annexure for the maps). These atolls which belongs to north and north central region of the country.

Information on existing potable water systems and dry season data was projected onto maps. This information included, islands with completed, ongoing and planned rainwater harvesting systems, desalination plants and water networks. It was highlighted that most of the completed water systems are located in north, north central atoll and Laamu atoll from south central provinces. This results were justified as number of islands requesting for emergency water was higher in the northern atolls. Laamu atoll's water systems were donor funded LecRED projects and government funded projects.

4.1.1. International Best Practice

In addition to the documents above, international practices from similar contexts to Maldives were briefly studied to get a better understanding of how a water security plan should be developed.

It is difficult to manage what is not measured (WSP,2015). A vision statement which was made in WSP toolkit. The output from the above documents were review and summarized into water security improvements (WSI) guiding principles for water security planning which could be applied to our context. Following are the principles (SWP);

- 1. Pragmatic focus on specific water risks
 - a. Translate priority water risks into specific goals
 - b. Explore and define possible water security activities
- 2. Engagement and mobilization of water users
- 3. A "systems thinking" approach to address causes and not just symptoms
- 4. Robust decision-making that considers uncertainties
- 5. Negotiated solutions that provide tangible benefits to different water user groups
 - a. Finalize and validate the action plan
- 6. Science-based actions that combine infrastructure development with water management, behavior change, and institutional improvements
- Adaptive management and learning to improve over time and build the capacities
 of stakeholders
- 8. Sustainability through economic efficiency, environmental soundness, and social equity
 - a. Perform the funding "reality check"

The main reason for reviewing these documents during the inception stage to formulate a research framework for the water security plan and to define parameters for data collection. This would be detailed further in the following sections.

4.2. Government Policy Change

It is important to note that during the inception of this project governments policy direction is to link with population with type of water systems established in islands (WATSAN, 2018). This policy suggest population is an indicator for development.

However with the new government the policy has shifted to develop water and sewer network for all inhabited islands independent of population or island size. The aim of the research was amended to meet the new policy change.

4.3. Survey and Data Collection

Based on the information from above maps, islands for site visits were selected. Stakeholder engagement sessions were carried out during these site visits. Islands from north to south was selected identify if there were any correlations.

In selection of islands criteria were set to include islands with frequent and consistent request for emergency water requests, islands with completed water systems and community managed water systems (Sh. Komandoo). The island are color coded by their respective administrative regions of Maldives. Following is the information is tabulated form.

Based on the desk review, a qualitative semi-structured questionnaire was designed to collect data to understand the challenges with current operating procedures of water management. The following three groups were selected to administer the survey.

- 1. Stakeholders of the island
- 2. Island based water supply operators
- 3. Government Institutions and service providers

Survey was intended to be truth seeking and explorative to identify deeper recurring issues. The main objectives of the survey were:

- Review of current operating procedures for water management for the whole island.
 This includes domestic household tanks, public storage tanks and water production center.
- 2. Identifying operational challenges for water management for the above mentioned areas.
- 3. Understanding island level and individual capacity to adapt water security procedures (willingness to adapt to the solutions proposed)
- 4. Attain an understanding for new baselines for cost and services population

4.4. Review of existing equipment used for water management

As shown in the table above in section 4.3, 4 out of the 8 islands visited experienced potable water shortage in dry season. Via a visual inspection of the water tanks, connection details and their location was identified. However it is important to note that this is insufficient data to make a conclusion.

Nonetheless, the water tanks are in good working condition and it located within 4000ft as per the 2017 guidelines by ME. Furthermore, it is important to note that no island had connection pipes with them. It was informed that the supplier brings the connection pipe (please refer to the cost and type of the pipe section 8.3).

Analysis of the collected data helped to arrive at an updated baseline for the affected islands and population. The two graphs below show the figures.

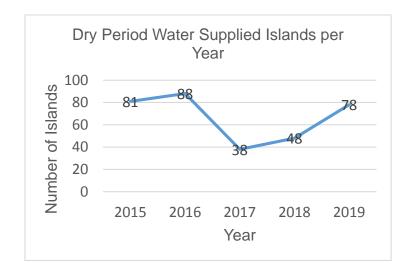


Figure 3 Dry Period Water Supplied Islands

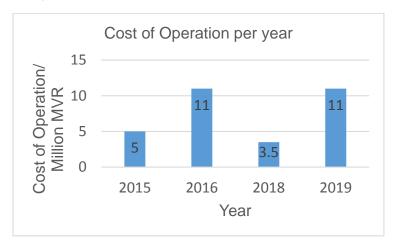


Figure 4 Cost of Operation per year

The graphs show steep decline in the number of serviced islands and cost of operation from year 2016 onwards to 2018. However in 2019 the numbers has risen back again. The exact reason behind the numbers are unknown as this plan making process is being carried out in 2019. Further information is required to make a conclusion for the 2019 results.

Please note that the above section has been summarized for the benefit of the readers and be advised to refer to the inception report of this project for further details of this section.

5. SITUATION ANALYSIS

Based on the research findings the following situation analysis table was compiled. This table has been split categorized into legislative, operational and behavioral challenges in potable water distribution and management. The intention of the Potable Water Security Plan is to address these challenges as per the objectives highlighted in this table.

6. POTABLE WATER SECURITY PLANNING

Aim of this Potable Water Security Operational Plan is proposed to reduce the need for dry season water supply. Nonetheless, as a nation we need to be disaster resilient. Hence emergency water supply procedure cannot be eliminated completely.

This plan consists of two parts. Part 1 is called Water Security Strategies. These strategies are designed to ensure potable water security via continuous, short and long term activities. Part 2 is dry season water supply procedure. Part 2 will be activated if potable water security is not ensured by Part 1 strategies.

7. PART 1: WATER SECURITY STRATEGIES

Water security strategies consists of three types of strategies. They are continuous, short and long term strategies. The following sections will present these strategies, activities and responsible parties respectively.

7.1. Continuous Strategies

Continuous strategies are year around strategies which needs to continue during both wet and dry season. These strategies are to be implemented independent of achievement of both short term and long term strategies.

7.1.1. Rainfall Alert System

Maldives Meteorological Service (MMS) is currently developing a Mobile Application and Common Alert Protocol (CAP) System for weather alerts. This strategy proposes rainfall alerts to be generated, shared and informed through necessary platforms such as instant messaging and social media. This alert will act as a reminder and encourage people start collecting water.

It is important to highlight here that these rainfall alerts may not be island specific, nonetheless can predict rainfall for atolls a week in advance. Further studies can also be carried out in weather modelling to more accurately predict weather.

7.1.2. Measurement of Potable Water Levels

The intention of this strategy is to study year round potable water levels to understand whether the issue is with lack of storage or challenges in rainwater collection. From the information provided ¹by MMS we can conclude that Maldives get sufficient rainfall during wet season to cater to population requesting emergency potable water.

Furthermore, if existing water stock in islands can be monitored and managed well it can help avoid the need for emergency water supply by preparing for the situation in advance. This information would be essential to ensure water security. It is proposed to identify existing water levels through 2 options;

Option 1A: Manually Measuring Water Levels via Tapping

Council staff or with the help of NGO's water levels in existing water tanks need to measured. The idea is crowd source information and work as much as possible. The manual process of collecting water proposed here is by tapping or via a measurement tape on the exterior tank wall to see whether it's full, half or empty. This information will suffice to generate number of liters as most community and household tanks are 2500 to 3000 liters.

The data collected needs to be updated to the Water Management Portal² by the council's administrative staff. It is advised to update the reading every quarter 3 months for minimum community tanks. For affected islands data should be update every month during dry season. Data can be collected in the following table format.

Option 1B: Manually Measuring Water Levels via Water Level Indicators

Slight Tube

A sight tube is our most popular method of knowing how much water is in your tank. It features a high quality polyurethane tube that will resist sun light discoloration. We weld two ¾ inch fittings into your tank. One at the bottom and one at the top. A ¾ three-way valve is installed in the bottom. A 90 at the top. The ¾ tube runs between the two (Wright Tank & Steel Fabrication, 2019).

Target Gauge

Target gauge is the method for knowing the water level in your tank from a distance. The target gauge gives you the water level of the tank at all times. It works on a pulley system with a stainless steel float on the inside and a gauge board on the outside. The float and the gauge are attached with a stainless steel cable. Two stainless steel stringers are attached to the inside of the tank. These two stringers keep the float lined up with the gauge. All the parts and pieces that are attached on the inside of the tank are made out of stainless steel. The gauge board on the outside is made from galvanized steel (Wright Tank & Steel Fabrication, 2019).

Option 2: Measuring Water Levels via Smart Water Level Indicators

Smart Water Level Indicator to be connected to community water tanks. This information can be fed into the Water Management Portal in real time. Cost of an indicator is MVR 8,000 to 9000 (\$ 500 to 600). Assuming that we are providing 10 indicators for each island. Total cost for 48 islands (number of islands requested for water in 2018) would be MVR 4,032,200. Please note that it is assumed that this indicators can be operated with the existing internet packages in the islands. Furthermore this cost does not include any maintenance costs.

Two options can also be integrated where water levels from households can be measured using tapping method and smart water level indicators can be used for community water tanks.

7.1.3. Education and Awareness Campaigns

Educating the public on potable water security and safety is a continuous process where by local councils, ME, MFDA, CSO's, and NGO's needs to be actively engaged. Two focus areas of awareness campaigns is proposed for islands with potable water shortage.

1. Water Conservation

From existing socio economic reports³ it is evident that people are satisfied with household drinking water. With proper water quality assurance measures such as

integrating tanks with carbon filters rainwater is once source of potable water to fight water shortage.

With sufficient rainfall during monsoon season, it is important to take measures to increase water storage. While the councils are working with government to increase community storage capacity, it is important to advocate to do the same at individual level as well. Unutilized or underutilized community water tanks should be identified via surveys. This includes tanks in households as well as public buildings such as mosques etc. Clean or repair these tanks to initiate rainwater collection from these tanks.

It is crucial to advocate for collecting rain water as it is a free potable water source. Local community should be encouraged to clean their roofs for dry season and increase their water storage capacity by purchasing additional household water tanks to prepare for dry season.

2. Water Quality Assurance

It has been identified through reports and surveys that most the people do not use the emergency supplied water for drinking. While there are many factors to why they do not use one of the main use is lack of water quality assurance.

Water quality should be checked via testing kits to give the assurance to the public. Once the public is informed of the testing parameters and (e.g. chemical and biological properties) and the outcome of the results is shared, general acceptance of emergency transported water will be more.

Furthermore water quality can be tested by individuals as well. For instance bacteriological H2S field test bottle can be made available in pharmacies operated by State Trading Organization (STO). This would increase public confidence in supplied emergency water.

This will be important to shift the notion that states rainwater is always safer than desalinated water from networks. Currently, few people use desalinated water from networks for drinking due to heaviness although it is proven to be safer than rainwater.

7.2. Short Term Strategies

Short term strategies are strategies targeted to be achieved within 1 to 3 years. The aim of these strategies is to achieve water security at island level.

7.2.1. Increasing Community Water Reserve by increasing Catchment Areas

1. Rooftop Water Catchment Areas

The common practice in islands is to collect rainwater via a dedicated roof connected to community HDPE tanks. However, there are public buildings such as council building, health centers or hospitals, mosques and schools which own large roof areas.

This strategy proposes to use all available roof spaces for rainwater collection independent of owner of these buildings. Currently, these roof spaces are unutilized as councils they are out of council's jurisdictions. It is important to look beyond institutional barriers and utilize these roof spaces as rainwater catchment areas. It is also important to highlight here that in most islands institutional buildings mentioned above are located in close proximity.

Roof spaces can be utilized in two methods. Method one is to connect the rainwater down pipes directly to the community tanks via an underground network. Although this method may be expensive the underground pipes can later be connected to IWRM systems.

Method two is directly connecting the rainwater down pipe to HDPE tanks. This would be easier and cheaper. However, will require additional land spaces. Nonetheless either of the two methods will help increase community water reserve.

2. <u>Underground Water Reserve Tanks</u>

Land scarcity is a challenge in many islands of the Maldives. Increasing water storage facilities at ground level is difficult. In order to find an alternative solution this strategy proposes new construction such as public buildings and parks to develop underground rainwater collection tanks.

This can be ensured by adding underground rainwater collection tanks as requirement in Planning and Development Guidelines or Building Code of the public buildings and parks. The primary use of the water reserve should be for potable uses. Other use may include firefighting and greening purposes. This can be a mandate of ME and MNPI to work together as a compliance code for public buildings in developing the Building Code.

3. Increasing the Number of Community Tanks

With Maldives, getting sufficient rainfall during monsoon season, a very straight forward answer to some islands maybe just increasing the number of community water tanks. This can be done by combining the unutilized tanks in household, mosques and other buildings already established on the island. Islands requesting 10 tons or lower every year can address their shortage with a few additional water tanks. However, this step should be taken after the studying the island's conditions to see if the problem is purely lack of storage capacity and not operational in nature. These tanks can be proposed as part of IWRM system which can be repurposed when the water network are built in the island.

7.2.2. Increasing Participation of the Private Sector in Water Supply Services

1. Encouraging Private Companies

It is important to take necessary step to encourage participation of private companies in providing water supply services. The current desalination plant regulation allows only large scale industrial operations or serving a population above 200 people. These conditions can be relaxed to make it more attractive to businesses.

Furthermore, through governments SME development initiatives, business proposals to supply water in effected islands can be priorities and incentivized. With

the development of more small business there is room for healthy competition to result in more quality services for the public.

2. Resort Sector Participation

Resorts operate in every atoll of the Maldives⁴. Through an organized manner, e.g. choosing resort in 50Km radius of affected islands, ME can advise resorts to supply desalinated water to affected islands within a selected service area. Resort produce water to cater for their development. Resort can systematically supply to affected islands when reserve reaches a certain threshold. This need not be limited to dry season, but can continue all year round till islands ensures water security. This can be part of their CSR program too. Legal instruments needs to be developed for resorts to take responsibility.

7.2.3. Increasing Participation of Community Groups in Water Management Services

The term community groups here is targeted at CSO's, NGO's and Women's Development Committees (WDC's). Currently none of these groups are involved in any water management services.

With the help of social service workers and start up grants, these groups can earn by helping out in water management services. For e.g. cleaning of the roof tops has been identified as a challenge for households to collect rainwater. The groups can provide cleaning services for a small charge. Moreover, councils lacking staff support is also in issue. These groups can be engaged in measuring potable rainwater levels in community tanks and households.

In islands with water networks operate kiosks at harbors. These kiosks sell water to fishing and passenger vessels. Currently these kiosks are operated by islands businesses.

Under this strategy it is recommended that instead of business, development of water standards/guidelines and reference tools to enable CSO's to be empowered to become more involved. The idea is that the profit they generate to be utilized in water management services mentioned above. With a strong transport network these groups can even extend their reach to neighboring islands. This activity will help increase water reserves in island acting as water supply hubs as well as help affected islands. Nevertheless, further details such as sustainability and profitability needs to be further studied in order to measure the success of this activity.

7.2.4. Packaging Filtered Potable Water

As mentioned previously most the people do not use the emergency supplied water for drinking. Mainly for two reasons. One lack of water quality assurance. Two is personal preference. Due to difference in taste of mineral water and desalinated water. Some people are more accustomed to bottled water. Which is adds to the plastic problem pertaining throughout the country.

This strategy proposes development activations of bottling factories in decentralized locations to produce reusable 5 gallon (19 liters) bottles. This is a more environment friendly approach which would eliminates single use plastic.

Furthermore, while packaged and sealed water 5 gallon bottles is equivalent to the market price for 5 liters bottles, it also gives people comfort of receiving quality uncontaminated water. Below is a cost comparison between 5 liters and 19 liter bottles;



- Assuming a person needs 10L per day;
 for a 7 days = 70L
- 5 Liters x 14 Bottles (70 liters) = MVR 15 x 12 = MVR 210
- 19 liters x 4 Bottles (76 litres) = MVR 53 x 4 = MVR 212
- Cost a dispenser is MVR 800

7.3. Long Term Strategy

7.3.1. Development of a Water Network

Long term strategy is targeted to be achieved within 5 years. One strategy is proposed under this plan, development of water network the island. This strategy aligns with the government's pledge to ensure that no island come under shortage of drinking water, establish clean drinking water facilities in all islands, minimize cost and struggle for drinking water and reduce plastic bottles by ensuring that water provided by water companies is most suitable for drinking.

To ensure sustainability and reduce operational costs, it is recommended to develop IWRM systems where by water supplied to the household would be a combination of desalinated water and treated rainwater. This way the current Rainwater Harvesting Systems (RWHS) being developed under GCF project can be integrated into the water networks. Furthermore, all water supply network providers have to follow EPA guidelines which ensure that supplied water is sufficient for potable use.

8. PART 2: EMERGENCY WATER SUPPLY SYSTEM

Emergency water supply system will be activated when and if islands are faced with potable water shortages. This is usually a dry season procedure however if required will continue year round. This system will only be initiated if the islands do not achieve water security through the strategies mentioned in part 1. Three types of water supply systems are proposed in this plan.

8.1. Type 1: Decentralized Water Supply System

Presently when emergency water is requested, water is supplied from K.Male', Hdh. Kulhudhufushi and R.Dhuavaafaru only. This water is supplied by FENAKA, a State Owned Enterprise (SOE) working as a contractor. FENAKA buys water from other utility service providers (mainly MWSC) to supply to affected islands. Emergency water supply report (NDMC,2016) that the cost of 1 ton desalinated water is on average MVR 239. This system type proposes decentralized water hubs to supply to affected islands within a specified radius.

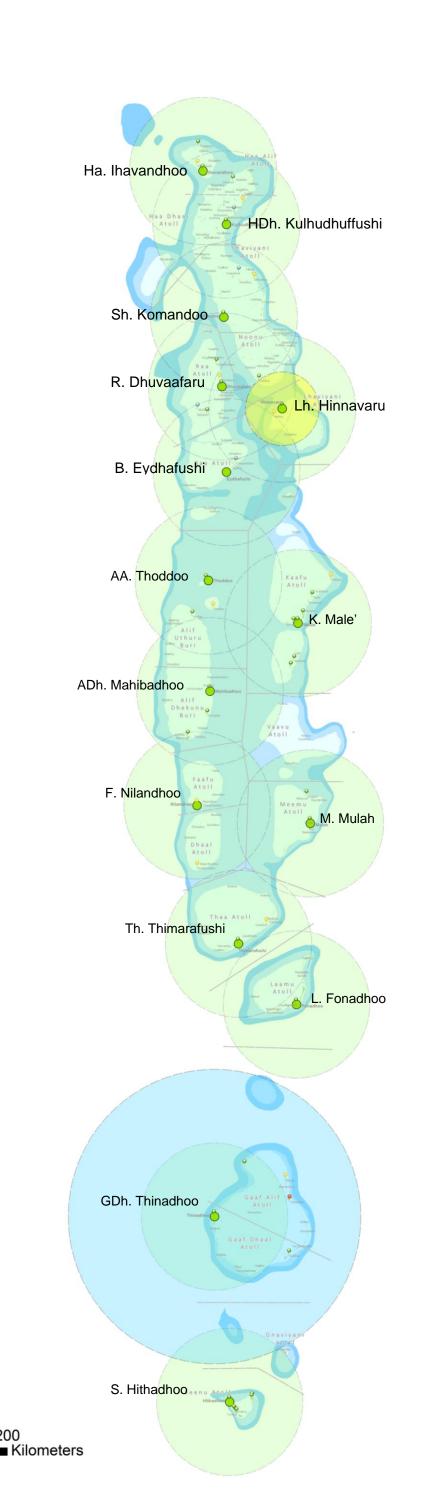
The following 15 islands are selected as water supply hubs under the following planning parameters. It is important to highlight here that preparation of a national spatial plan is in progress at this stage. Work has been done to align the hubs with the spatial plan as much as possible.

The service radius of these hubs are chosen as 50km with a reach time of 3 hours as a basis. Some hubs may have to service longer distances while others for shorter one. Water is to be supplied via cargo vessels to the islands. It is targeted to do up and down trips within a day. Time of the trip is measure assuming the average travelling speed of a cargo vessel is 10 mile/hr (16km/hr).

Most frequently water is transported for Male' to islands with water shortages. Distance for Male' Atoll to Ha. Atoll (the northern most atoll) is roughly 300 km. Fuel cost comes up to MVR 21 per kilometer. With the proposed 50km service radius a cost saving of almost 83% is achieved from fuel costs alone. The table shows the estimated fuel costs for a round trip.

Maximum amount of water supplied to an individual island in the year 2018 is 75 tons. From the above table it can be concluded that Kulhudhuffushi can supply up to 200 tons to affected islands per day without compromising required amount of water for the islands use.

Estimated investment costs of this type of water supply system is MVR 800,000 per hub. For 15 hubs MVR 12 Million. The main cost incurred is for a cargo vessel to carry water from the hubs to the islands. The following table provides a rough breakdown of the costs.

8.2. Type 2: Supplying Bottled Potable Water

This type is very much similar to type 1 as it is also a decentralized service system. The idea behind proposing this system is not to add on to the widespread plastic issue but tackle the issue with a different approach.

From the findings of this project it is known that people do not drink emergency supplied potable water due to mainly lack of quality assurance. What this type is proposing is similar to the strategy proposed in part 1, i.e. supplying reusable 5 gallon water bottles to islands in case of emergency. Councils can procure water dispensers to distribute water to the public. If any household owns a dispenser, the water bottles can be supplied to the households directly.

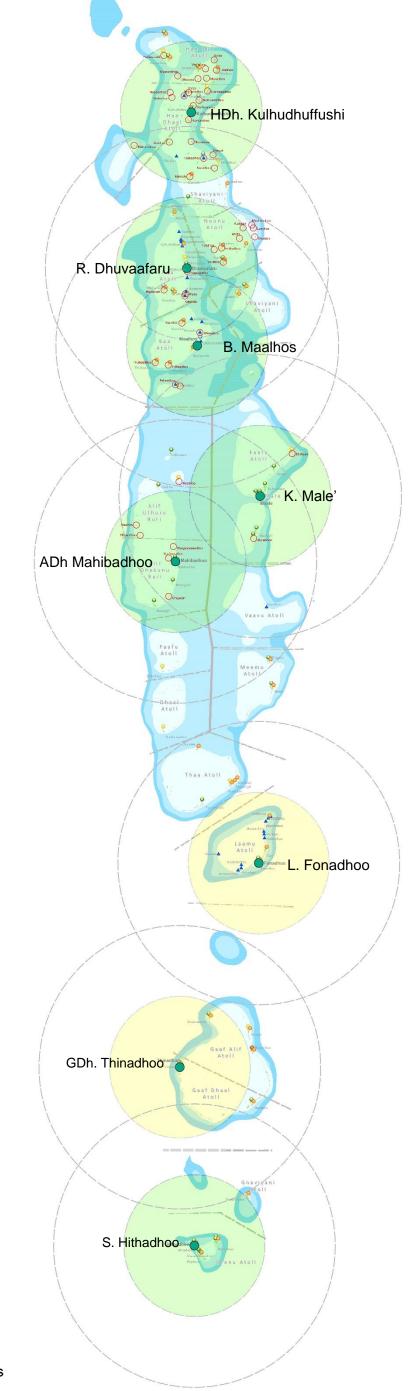
The following table shows the selected islands with bottling factories developed by utility service providers and private companies, in strategic locations to supply bottled for in cases of emergency. Similar to type 1 these islands will have service radius of 50 to 100km. It is important to note that currently these factories do not have the required molds to produce 5 gallons reusable plastic bottles. They have to invest in such molds to produce the bottles.

The investment cost of equipping the bottling factories with molds was not investigated for this plan. However, the following costs have been taken into consideration for the cost comparison exercise in section 5.4. It has been assumed that 2 water dispensers have to be supplied to minimum 50 islands. The rate of a dispenser is MVR 800. The following table provides a rough breakdown of the known costs.

8.3. Type 3: Portable RO Plant

The above two types include multiple steps and responsible parties⁵ before water can be supplied to affected islands. From the production stage to deliver more two parties are involved. Reducing responsible parties in one method to achieve greater operational efficiency.

In collaboration with NDMA, Maldives National Defense Force (MNDF) acts as the first responder to emergencies. MNDF coast guard services operates in strategic locations of the country. They can ensure that emergency water request prone areas highlighted in the heat maps⁶ already have their presence.

This type proposes to equip MNDF with a portable RO plant to supply desalinated water to affected islands during dry period. This RO plant should ideally be inbuilt into a sea vessel to acquire desalinated water for areas free from waste and garbage. In some cases shift is water current collects garbage in inner harbor areas. Current proposal is to have minimum one portable RO plant operating in each administrative boundary.

Furthermore, MNDF is mandated to produce sufficient water reserve for firefighting. After dry season passes, they can utilize the RO plants to increase water reserve for such tanks. Presently these tanks are located in islands with water networks and is filled with desalinated water. The designated service areas for the RO plants in 100km Radius. 5 portable RO plants are required to service the country. The following map highlights the service areas.

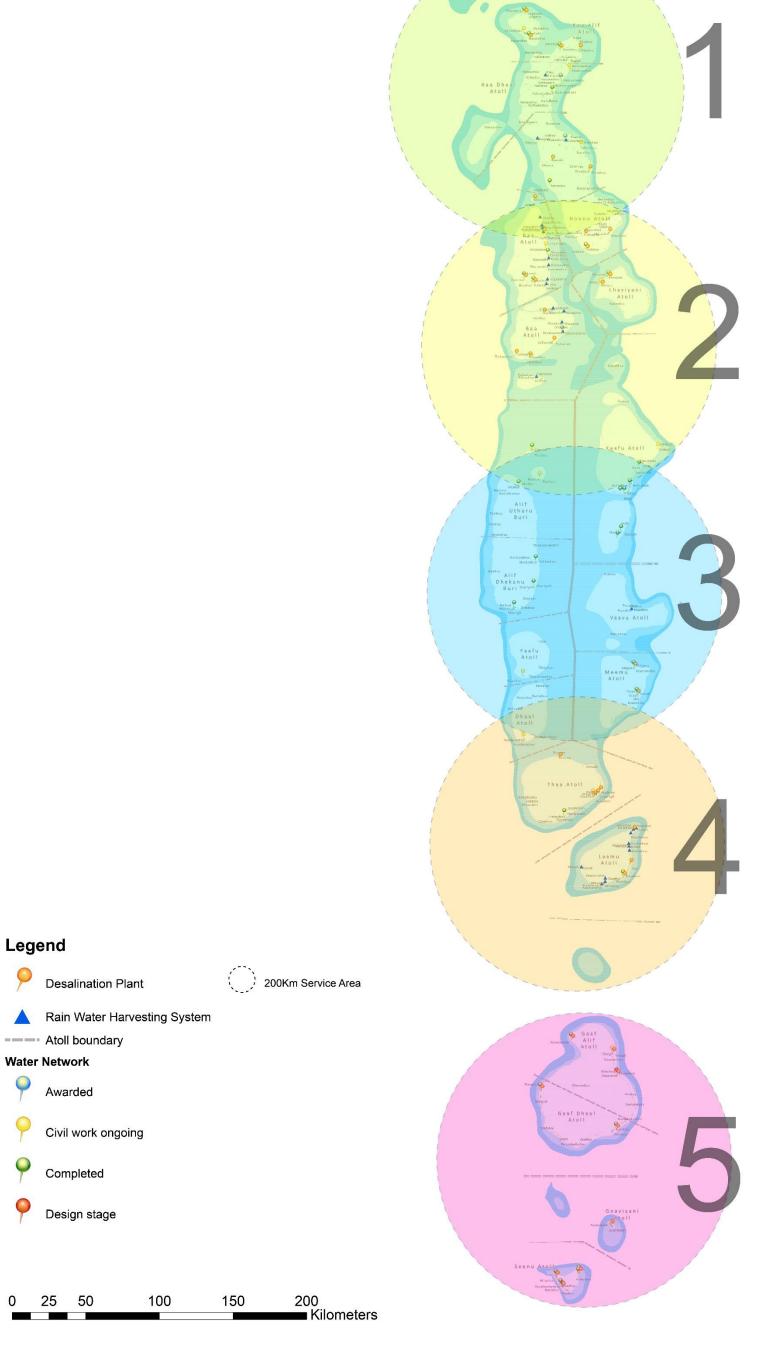


Figure 14 Portable RO Plant Service Areas

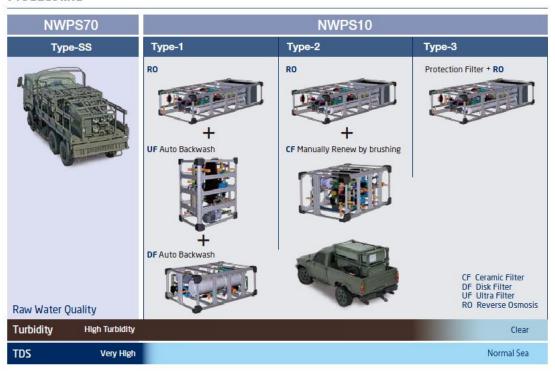


Figure 16 NEC Mobile Water Purification Product Line

Comparison shows that local model is slightly more expensive than the NEC model. However, in the local model accessories can be procured locally with ease compared to international brands. Furthermore, NEC models requirement trained workers to operate the system where as the local model can take advantage of existing institutional knowledge and promoted small businesses. Please note that these two models need to be studied further prior to concluding the most sustainable model.

8.4. Investment Costs Comparison of the Systems

The following table shows the costs of the systems proposed above. From the three types of systems, the system type with lowest investment cost is Portable RO Plant. However, it is important to note that operational costs of all the systems should be further studied to make a more accurate conclusion.

From the table it can be concluded that, the type 3 Portable RO plant is the most preferred type by stakeholders, followed by Type 1. Type 2 is the least preferred as clearly observed form the table. Furthermore, key areas were defined and the systems were scored further through a rating scale. From both exercises it can be concluded that emergency water supply system type 3 acquiring Portable RO Plants is the best way forward. In addition, ME can choose to have mix of two types to give a more efficient service. For instance type 3 for northern atolls and type 1 for central and south.

8.6. Emergency Water Supply System Operational Matrix

Each type of the Emergency Potable Supply System explain above is converted into step by step process. In order to enhance the coordination mechanism a water management portal ⁷should be developed to achieve systems integration. Each step is linked to a specific duration. Till the water management portal is established, councils can follow the current system. However based on the chosen system type, council may not have to report directly to the utility provider. In the proposed plan the responsibility is taken by ME. Nonetheless the first step for all system types are the same. For all the types to function effectively, existing water levels should be established (please refer to Water Management Portal under section 11).

Once the islands start updating the water levels every quarter and ideally every month during dry season, the water level trends can be identified. It is advised to report minimum 10 working days (2 weeks) prior depletion. The target is to supply water within 8 working days.

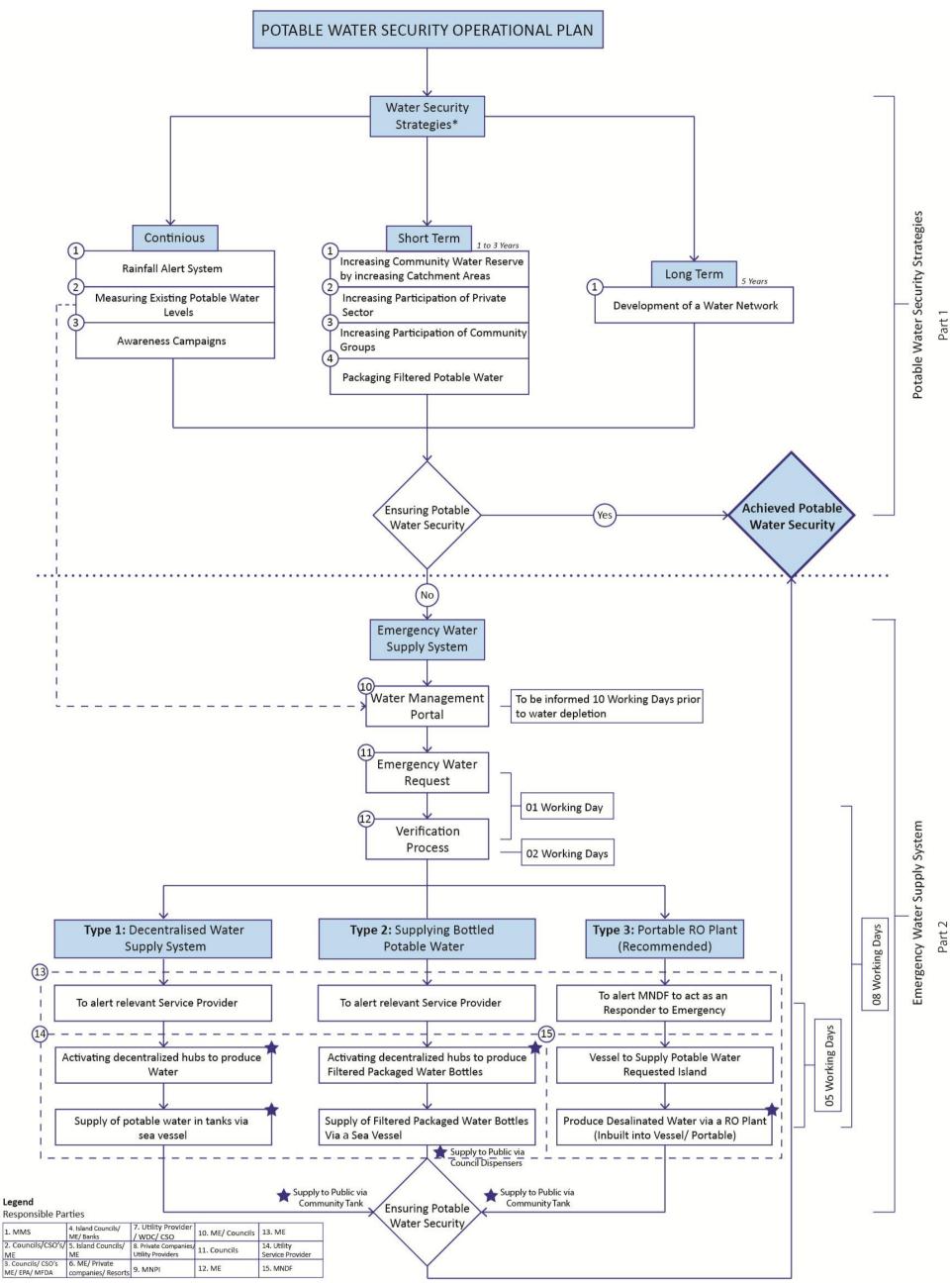

From those strategies following is a list of selected strategies where councils can lead at island level;

- 9. Measurement of Potable Water Levels (refer to section 7.1.2)
- 10. Education and Awareness Campaigns (refer to section 7.1.3)
- 11. Increasing Community Water Reserve by increasing Catchment Areas (refer to section 7.2.1)

The diagrams below underlines the actions of island councils during emergencies. This section aims to help mechanize and implement the plan at island level.

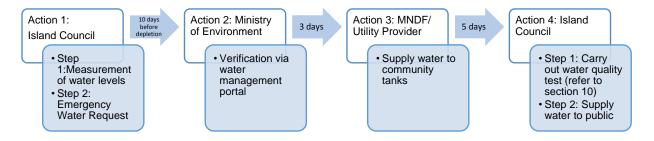


Figure 19 Dry Season Diagram - Type 1 & 3

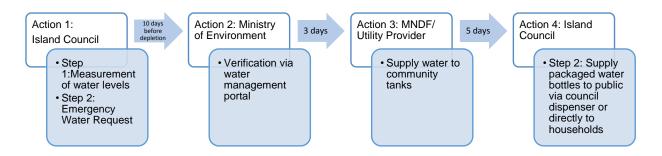


Figure 20 Dry Season Diagram - Type 2

10. MEASURES TO ENSURE WATER QUALITY

From the findings of the survey it is evident that water quality is a major concern among the public. A very important condition is implementing existing laws and regulations. Currently there are two legal documents⁸ ensuring water quality;

- Guidelines for drinking water (EPA)
- National Standard for Bulk transportation and storage of Drinking Water (MFDA)

EPA guidelines has clearly defined the water sample collection procedure as well as the testing parameters for drinking water. EPA conducts regular checks to ensure water supplied to the public fits their guidelines. However, EPA carries out this activity in islands where water networks are established and operational only. The quality of supplied water is not checked by EPA.

MFDA standard identifies the conditions of water carrying containers, fitting and vessels in detail. However, there have been challenges implementing the guidelines after NDMA handed over the emergency water supply operations to FENAKA. Quality tests are conducted at the source point by FENAKA during their emergency water supply operations. However, due to the limited resources, they are unable to verify the quality of water during the supply chain.

Throughout the course of preparing this plan measures to ensure water quality was discussed with the island level and government stakeholders. Such discussions and have been taken into consideration in the plan. The stars in the flowchart indicate water quality check points. Following are the recommendations proposed under this plan to implement such measures.

In addition to the above water quality can be tested by individuals as well. For instance bacteriological H2S field test bottle can be made available in pharmacies operated by State Trading Organization (STO). This would increase public confidence in supplied emergency water.

Cost Analysis of Bacteriological H2S Bottle

The calculations is made by taking the results of 2018 affected islands and population. As per the UNICEF website an indicative price for a kit is USD 1.53 (Bacteriological H2S field tst kit, 2019). It has been assumed that 4 kits will be required by each council or health center during dry season (1 kit per month). The cost incurred if a kit were to be bought by each household was also calculated. It was assumed that 4 people per household for the affected population. The kits for individual use can be sold from pharmacies.

10.1. Recommendations to ensure water quality

- All parties responsible in implementing the Potable Water Security Plan especially Emergency Water Supply Systems should comply with the guideline and standard set by EPA and MFDA respectively
- Staff from island hospitals and health centers to be trained to conduct water quality checks via water quality kits. For parameters reference can be made to the EPA guideline⁹
- 3. Water Quality Kits are to be distributed islands and should be readily available to buy at pharmacies for individual use
- 4. The trained personnel to check water quality at every check point indicated in the plan
- 5. Water quality checks to be carried out every month for community tanks carrying water for longer periods
- 6. STO can provide Bacteriological H2S field test bottles in island pharmacies for individuals to test water quality to increase water quality assurance
- Councils to send water in community tanks to be checked by laboratories for extensive studies. ME or LGA to take responsibility in monitoring the council duties. Laboratories are located in the following locations;
 - K. Male' / Hulhumale'
 - Ga. Koodoo
 - K. Himmafushi
 - S. Hithadhoo

11. WATER MANAGEMENT PORTAL

The above Water Security Operational Plan is proposed to be implemented through an online portal. To ensure operational efficiency of the plan is important to integrate the steps in the plan with the portal.

Currently ME is in the process of developing an online portal called Emergency Water Supply Portal to manage the water supply and distribution process. However to address the strategies proposed in the plan in a more holistic manner the portal has been reviewed and certain changes are recommend.

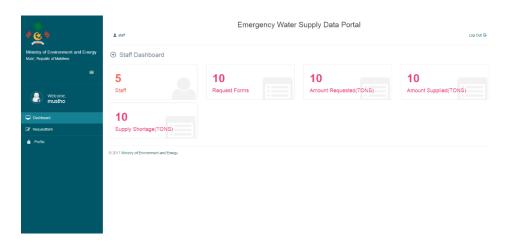


Figure 22 Screen Shot of the Emergency Water Supply Data Portal

11.1. Review of the Portal

Dashboard of the current water Emergency Water Supply Portal consists of the following tabs or categories:

- a. Number of request forms received
- b. Amount of potable water requested
- c. Amount of potable water supplied
- d. Supply shortage (TONS)
- 1. Categories b. and c. needs to be enhanced to indicate the hub supplying the water and respective amount. A decentralized water distribution mechanism will have multiple hubs.
- 2. Following are the categories to be introduced:
 - Potable water levels at community and household tanks in affected islands; as per the plan, the existing water levels measured in islands should be systematically fed into by portal by the councils
 - The above step is crucial for ME and service providers as a verification process
 - Daily water production and consumption of water supply hubs

11.2. Recommendations to enhance the portal

- It is recommended to change the name of the existing portal from Emergency Water Supply Portal to Potable Water Management Portal. Proposed change is to address all aspects of Potable Water Management.
- 2. Rainfall alert system¹⁰ for early prediction needs to be integrated into the system to compare the water collection trends with weather patterns.
- 3. The portal should consider and map out all residential, industrial and resort islands. It is important to note here that resorts are included as they can be potential water suppliers.
- 4. To integrate a cross check to monitor whether council/health centers carry out water quality check (refer to section 7)
- 5. Information should be visible in the dashboard in the form of interactive maps, charts and graphs. The image below shows an example of a GIS maps ¹¹showing the information above.

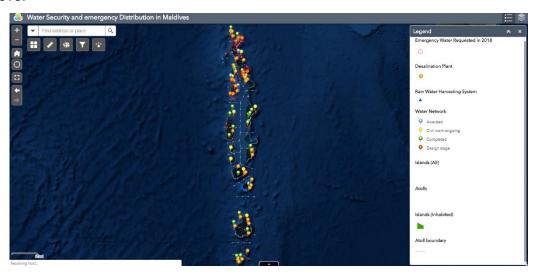


Figure 23 Screenshot of GIS maps

11.3. Verification Process

In the current practice, Emergency water supply requests in verified by a phone call or by staff for utility service branches from nearby islands physically visiting the island. With the setup of the water level measuring mechanism and regular updates to the portal, anomalies can be detected easily. If an anomaly arises a site visit can be carried out by a nearby hub to verify. If not the trends will not vary, in turn creating accountability for the councils and accurate data for ME to verify the entered data.

14. CHALLENGES AND LIMITATIONS

Throughout the course of this planning exercise challenges were met and the above presents plan hold certain limitations. Following list summarizes the challenges and limitations of the Water Security Operational Plan;

- *Time constraint:* The total duration of the project limits research and the ability to dive deeper into underlying issues.
- Lack of information sharing: Information we receive from government stakeholders (e.g. utility companies) is limited in terms of costs of equipment and services
- Lack of available data: Existing data is limited, and if available incoherent.
- Regulatory and legal framework under review: During the course of preparation of this
 plan many of the documents (e.g. National development Plan, Maldives Spatial Plan) are
 in draft stage which only provided limited information

15. FURTHER STUDIES

In addition to the strategies and systems proposed in the Water Security Operational Plan, there is room for further or extended studies with regard to this topic. The following list highlight certain recommended areas;

- Potable Water Security Operation Plan should be published, shared with and linked to National Emergency Operations Plan (NEOP) updated by NDMC
- Review of the conditions of the island tanks, the locations, equipment and connection details required to transfer water if distributed from Hubs or RO produced during emergencies
- All resorts have desalinated water networks. After identification of resorts in water shortage
 areas initiating discussion to provide emergency water supply service. Resorts have been
 mapped under this plan. Please refer to appendix D.
- Study the characteristic of islands with water shortages individually and propose island specific solutions
- Exploration of how ground water can be used as a potable water source
- Developing compliance codes to include water reserve tanks in public buildings with ME,
 MNPI and city councils.

It is also important to highlight here retention of staff with a good understanding of the underlying ideas of this plan is important throughout the implementation stages to ensure success. This will help address any challenges which may arise in a timely and effective manner.

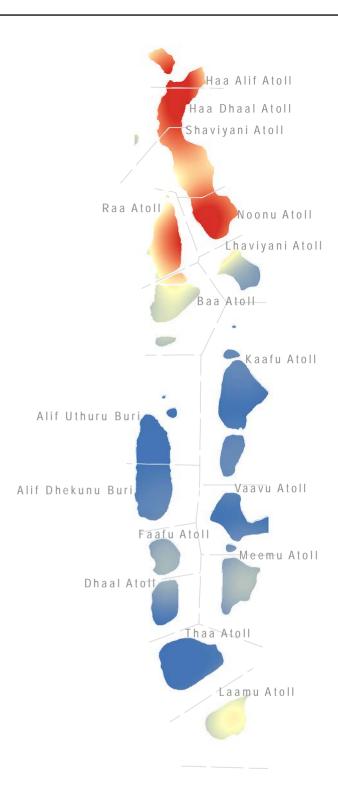

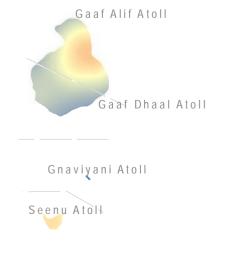

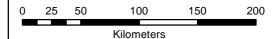

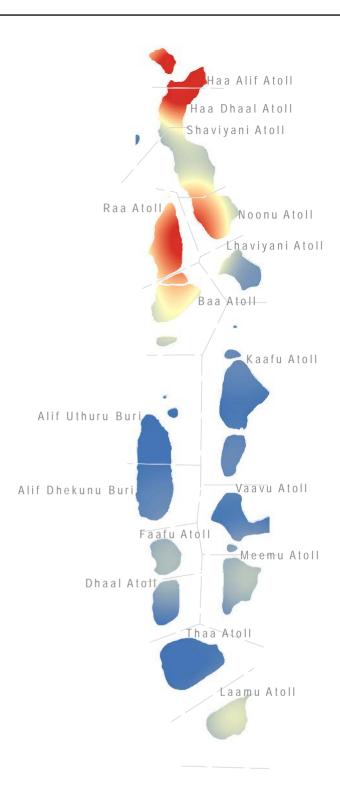

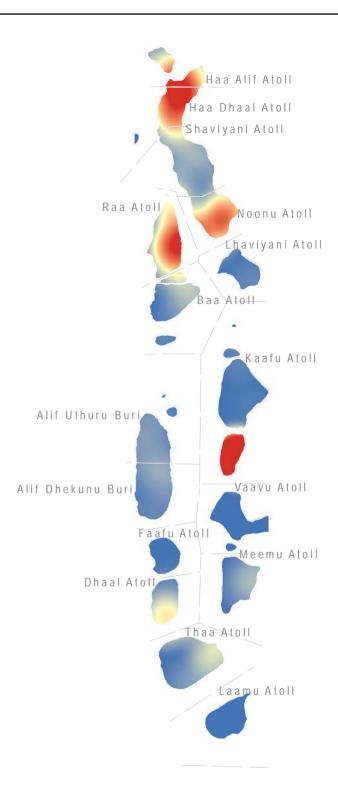

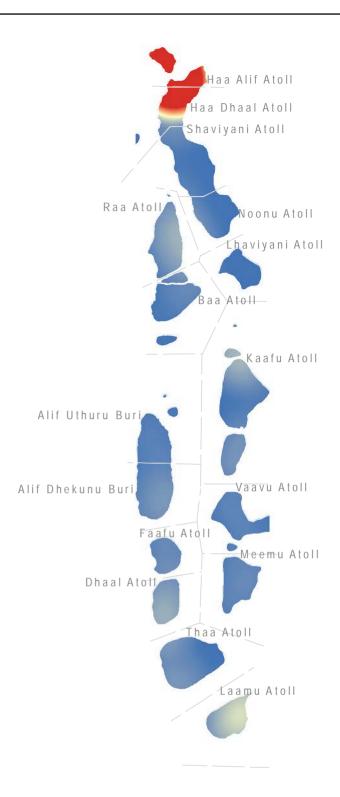

ANNEXURE B EPA DRINKING WATER GUIDELINES





GUIDELINE FOR DRINKING WATER

Sample collection procedure

- 1. If the sampling tap is metallic, apply surgical sprit around mouth of the tap both from inside and its outside. Use flame to burn it to disinfect.
- 2. If the tap is plastic then avoid the first step
- 3. Let water run from the tap for a minute.
- 4. Do not touch or get contact with the opening of the tap after disinfection.
- 5. Disinfected 125ml glass bottles shall be used for sampling.
- 6. Remove the cap from the sterile collection bottle, being careful not to contaminate either the inside of the cap or bottle.
- 7. Grasp the bottle near its base and allow the bottle to be field by the running tap.
- 8. Always keep the mouth of the bottle/container ahead of the hand so as not to contaminate the sample.
- 9. Replace the cap immediately after the fill.
- 10. Store the samples on ice immoderately for transport to the laboratory.
- 11. The date and time of the sample, the location of the sample, name of the island including Atoll (if the sample is to be taken to different island for testing) shall be labeled on the bottle.

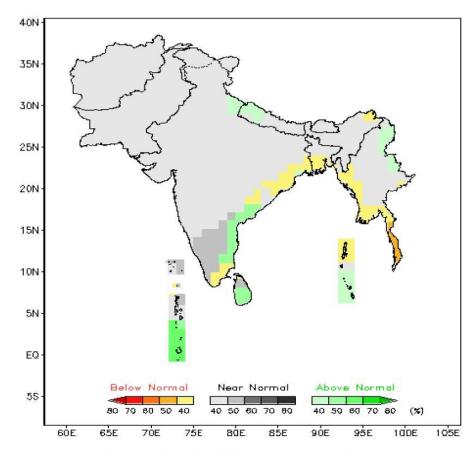

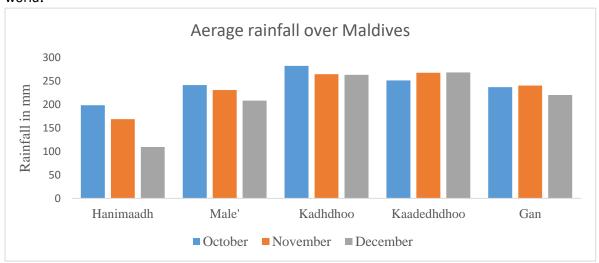

Consensus outlook for the 2018 OND season rainfall over South Asia.

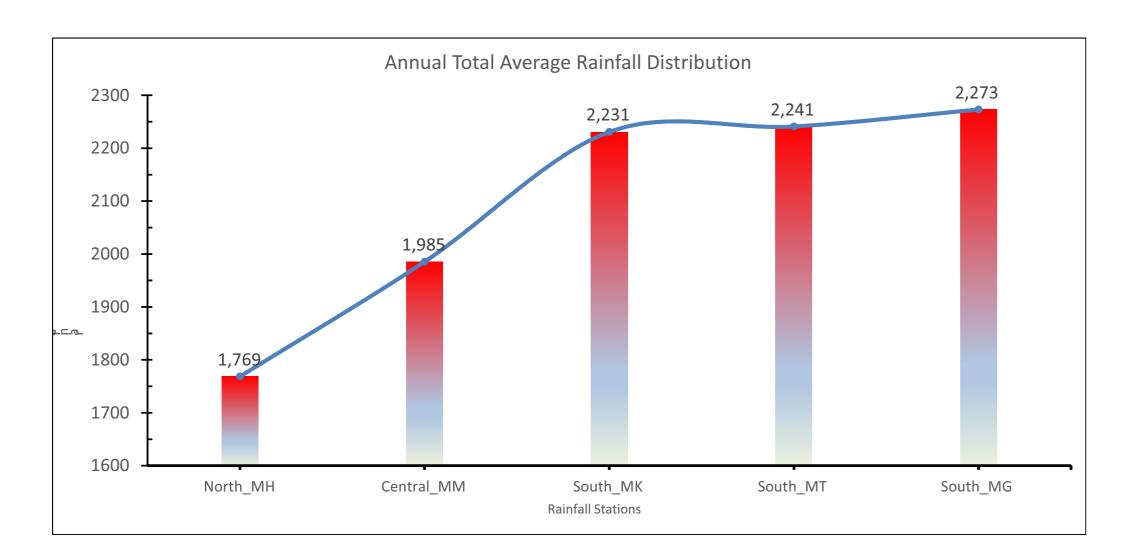

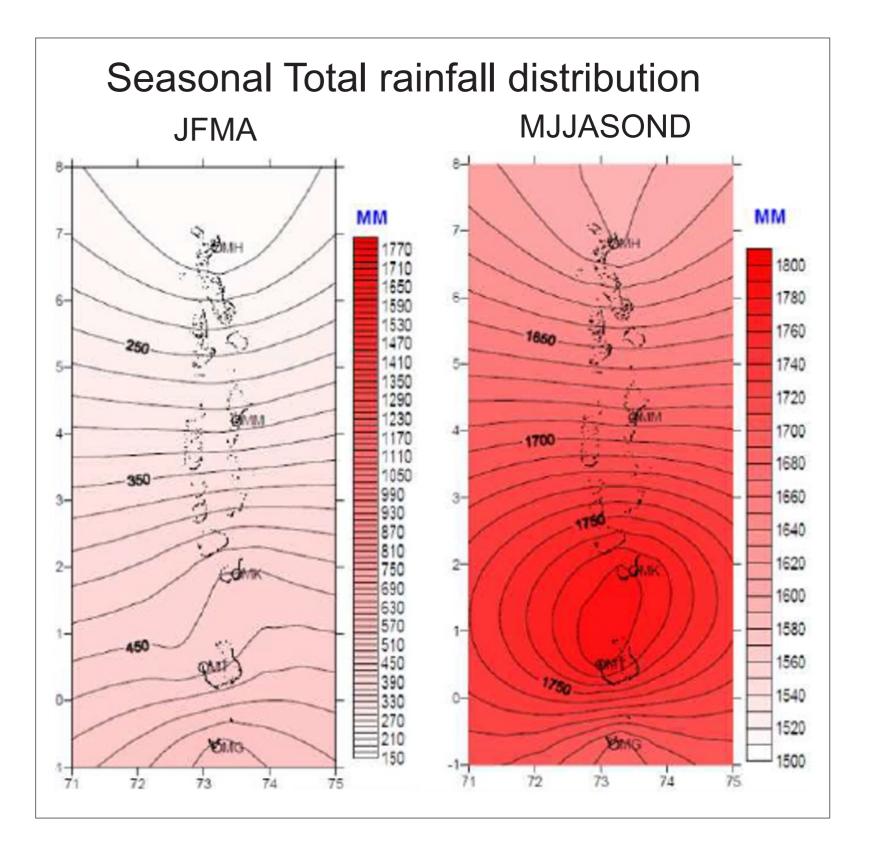
Annual rainfall over the country varies between 1760 - 2280 mm per year, while average temperatures range from 25°C to 31°C.

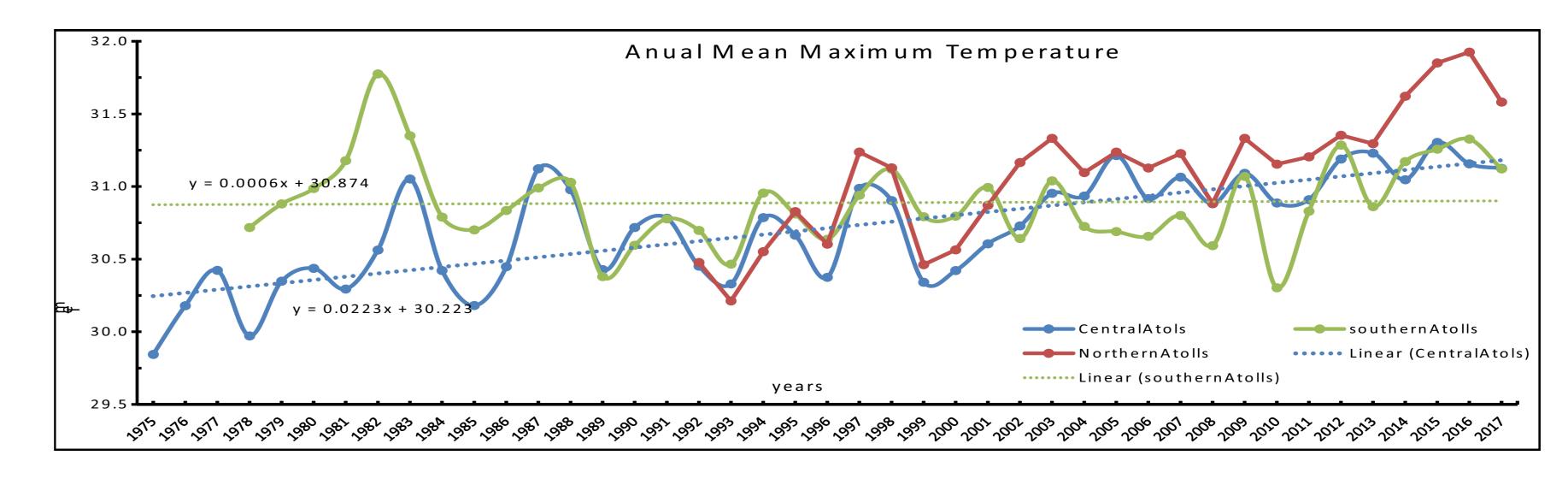

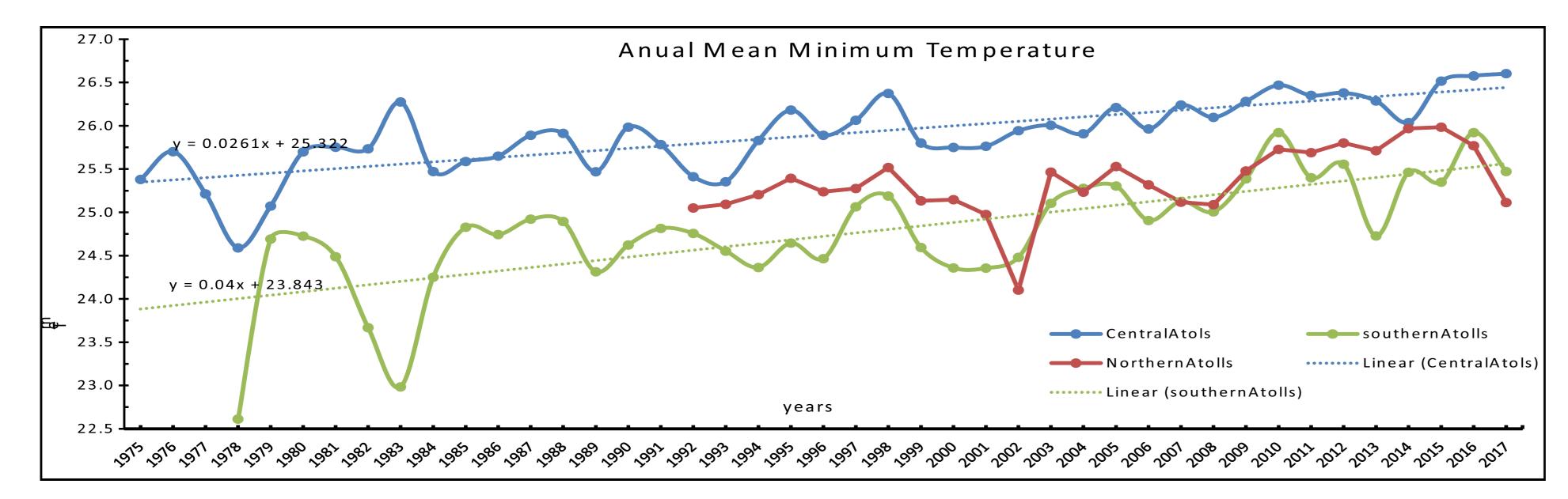

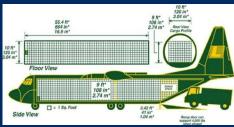
