### **1. POSITION SUMMARY**

- **Position Title:** Project Manager (PM)
- **Type of Contract:** 1 year
- **Thematic Area:** Water, Sewerage, and Waste Management
- **Location:** Based at the Ministry of Tourism and Environment in Male', with routine travel to islands/project sites
- **Monthly Remuneration:** All-inclusive fee of MVR 27,800 to MVR 32,000, depending on qualifications and experience

### **2. PURPOSE & BACKGROUND**

The Government of the Republic of Maldives, through the Ministry of Tourism and Environment (MOTE), is implementing the "Development of Water, Sewerage and Waste Special Projects". This initiative aims to provide safe water, adequate sewerage facilities, and safe disposal of waste, which are basic rights stipulated in the Constitution of the Republic of Maldives (2019). These obligations are further mandated by the Water and Sewerage Act (8/2020) and the Waste Management Act (24/2022).

### **3. OBJECTIVES OF ASSIGNMENT**

The objective of this assignment is the operational management and implementation of activities in accordance with project documents. This includes collaborating with the project team and stakeholder agencies to ensure efficient, effective, and timely project delivery.

### **4. SCOPE OF WORKS**

The Project Manager will be responsible for the following tasks:

- Assume overall operational management of the projects in accordance with government plans, policies, and regulations.

- Distribute responsibilities among team members, conduct staff appraisals, and provide performance feedback.
- Establish and implement monitoring mechanisms to achieve results in line with project objectives.
- Ensure procurement of goods, works, and services follows relevant government guidelines and laws.
- Review, evaluate, and finalize project reports and documents in a timely manner.
- Participate in periodic project site visits and report on-site activities.
- Coordinate the handover of island waste management centers to local councils upon construction completion.
- Identify and resolve implementation problems with guidance from the Project Team.

## 5. QUALIFICATIONS AND EXPERIENCE

- **Education:** Master's degree in Project Management, Engineering, Environmental Science/Management, Water Resources, Business Management, Financial Management, Sustainable Development, or Waste Management.
