# **CONSULTATIONS PLAN**

## **Maldives Clean Environment Project (MCEP)**

### Zone V and IV

#### 1. Introduction

Through the donor assistance of World Bank, the Government of Maldives is currently at the initial phase of implementing the Maldives Clean Environment Project (MCEP). The project became effective on 18 September 2017. The primary objective of this project is to establish an integrated solid waste management system in Zone 4 & 5 comprising of 43 islands from Meemu, Faafu, Dhaalu, Thaa and Laamu Atolls.

This project will provide funding for the development of 43 Island Waste Management Centres (IWMCs) within this region. The project will also assist in gap filling in the MEMP Project area, the North Central Region (Zone II) on inhabited Islands the project has previously worked on in the Raa, Baa, Noonu and Lhaviyani Atolls. The primary purpose of these IWMCs are to collect and transport island waste to the IWMCs for further processing and treatment and for transfer to the Regional Waste Management Centre (RWMC). The IWMCs will include, collection and transportation equipment and vehicles, island organic waste treatment facilities, island in organic waste separation and bailing facilities.

Further to this, the project will finance the construction and installation of the RWMC as the final disposal technology. The RWMC is likely to include a harbor, an incineration plant, including all the necessary civil and electro-mechanical works, plants and equipment and waste transportation vessels.

#### 2. Stakeholder Consultations

The project manager and the environmental and social safeguards officer (ESSO) has undertaken a number of consultations during project preparation. A summary of these consultations are provided in Annex-11 of the Environmental and Social Assessment and Management Framework (ESAMF). Further consultations will be undertaken as part of the feasibility studies and assessments. In addition to this, the Project Management Unit (PMU) and the Island Councils are required to undertake continuous consultations with stakeholders and report on a regular basis.

The consultations plan detailed in section 3 provides details of the stakeholder consultations planned for the duration of the project. Location, date, targeted audience and responsible person for each activity is specified. However, the location and dates are indicative and may vary depending on the actual delivery of the project activates.

### 3. Consultations Plan

The consultations detailed in the table below are proposed to be undertaken under MCEP. The consultation process aims to provide opportunities for community involvement and education and ensures that the views of stakeholders are taken into account in the implementation of the project.
