As the advertisement ((IUL)438-ENV/438/2020/113), issued on 07th July 2020, was cancelled as per We did not receive any bids, regarding the advertisement number (IUL)438-ENV/438/2020/168 (7th October 2020) requesting for bid proposals from interested establishments for the work mentioned in the title. Therefore, The Ministry of Environment (MoEnv) is advertising, for the fifth time, for interested bidders to submit bids for this project. The Government of the Republic of Maldives through the Ministry of Environment is implementing "Go Green" financed by the New Zealand government and intends to apply part of the proceeds for the selection of an establishment for replacing and/or retrofitting HCFCs and HFC equipment with R 290/R600a/HC blend or low GWP alternative. This project intends to completely phase-out HCFCs and HFC in an establishment by replacing the HCFC and HFC charged air-conditioners and refrigeration systems by replacing and/or retrofitting with R290/R600/HC blend or low GWP alternative. The Ministry now invites sealed bids from eligible and qualified bidders for this project.
