1. Introduction & Background

The Government of Republic of Maldives represented by the Ministry of Environment has allocated funds under the project Enabling Activities for Kigali Amendment, for "Translation of Good Servicing Practices for Flammable Refrigerants: A Quick Guide' Booklet to be used for servicing practices by the technicians and in customs ports by the custom officers in the Maldives. The ministry is seeking a qualified individual or a team to undertake the above-mentioned Task.

Enabling Activities for Kigali Amendment is implemented by Ministry of Environment with support from UNEP and funded by the Multilateral Fund for the Implementation of the Montreal Protocol.

Kigali Amendment proposes to phase down the production and usage of hydrofluorocarbons (HFCs) by mid-2040 and offers an opportunity to countries for flexibility in doing so according to the principle of common but differentiated responsibilities. HFCs are man-made chemicals that are widely used in airconditioning, refrigeration and foam insulation and are powerful greenhouse gases, more potent than carbon dioxide. As such they contribute significantly to climate change. KA is therefore a significant milestone in the international environmental protection as its achievement could help to reduce the global temperature rise by 0.5 degree Celsius by the year 2100.

The provisions of KA include specific targets and timetables to replace HFCs with lower Global Warming Potential (GWP) alternatives, and restriction from trading in controlled substances with states that have not ratified it. KA also mentions the importance of energy efficiency of cooling technologies and proper management of chemicals throughout their life-cycle including at the end phase for safe disposal and destruction of refrigerant gases.

2. Scope of Works

The scope of this service is to translate all 54 pages of the A5 sized booklet from English to Dhivehi language. All deliverables should be provided in Microsoft Word Format. A soft copy of the booklet is attached to this advertisement and available through the Ministry website.

Translation must be accurate and literal Dhivehi translation of the Quick Guide
