INVITATION FOR BIDS

Development of a Public Awareness Campaign on Energy Efficiency Standards and **Labeling Program in the Maldives (First Announcement)**

The Ministry of Environment (ME) has received financial assistance from Global Environment Facility (GEF) administered by the United Nations Environment Programme (UN Environment) to reduce greenhouse gas (GHG) emissions through energy efficiency in the building sector under the project Strengthening Low Carbon Energy Island Strategies (LCEI) and intends to conduct an awareness campaign aimed for the public regarding energy efficiency standards and labeling.




