6. Photos submitted shall comply with the laws and regulations of the Maldives.
7. To ensure eligibility for the contest all entries must have 3000 pixels at the long end.
8. If you choose to include people in your photos, you are responsible for obtaining the necessary releases from the individuals depicted, and you must be able to provide copies of those releases to the Ministry upon request.
9. Ministry of Environment, Climate Change and Technology reserves the right to disqualify the submitted images that involve human nudity, the willful harassment of wildlife, damage to the environment by the photographer, put any individual or animal in danger, or infringe on the rights of any other photographer or person.
10. The competition is eligible for Maldivians only.
11. Employees of Ministry of Environment, Climate Change and Technology and agencies under the Ministry are not eligible to participate in this competition.
