## Water resources protection and management regulation

Introduction	1.	This is a Regulation formulated pursuant Section 58 (a) of the Law No: 8/2020 (Water and Sanitation Act), with reference to Section 17, 18, 19, 20 and 23 of the Law No: 8/2020 (Water and Sewerage Act) and Section 20 of Law No: 26/2020 (Utility Regulatory Authority Act).		
Title	2.	The title of this Regulation shall be "Water resources		
		protection and management regulation".		
Objective	3.	The objective of this Regulation is to establish and implement a mechanism and to establish regulatory framework for the sustainable usage of the available water resources by preservation, protection and development of the resources in order to achieve its benefits to the fullest.		
Enforcement Authority	4.	This Regulation will be enforced by the Utility Regulatory Authority.		
Authorization	5.	All authorizations to be granted for the enforcement of this Regulation shall be given in writing, by the Authority or by personnel designated by the Authority.		
Protection and maintenance of the ground water lens	6.	<ul> <li>(a) Any action that may endanger the groundwater lens is prohibited, as it is a protected resource under Section 18 <ul> <li>(a) of Act No: 8/2020 (Water and Sewerage Act)</li> </ul> </li> <li>(b) To ensure sustainable management of all water resources within the jurisdiction of each island, the "Water resource conservation and management plan" of the island shall be formulated by the council of the island, in consultation with the Ministry and the Environmental Protection Agency, passed by the Authority and published in the gazette within 12 (twelve) months of the commencement of this Regulation.</li> </ul>

		(c)	The plan formulated according to sub-section (b) of this Section shall be implemented by the council of that island.
		(d)	The Authority shall ensure the implementation of the plan formulated according to sub-section (b) of this Section.
		(e)	In situations wherein dewatering of ground water is required for construction and industrial purposes, it shall be done according to the regulation on dewatering of ground water for construction and industrial works.
		(f)	For various industrial and commercial purposes, it is prohibited to extract, sell, or use water from the ground water lens or wetlands or from naturally formed waters.
		(g)	Notwithstanding subsection (a) of this section, the regulation does not prevent the extraction and use of ground water by digging or collection and use of rainwater or extraction and use of seawater for personal use.
		(h)	In any situation requiring extraction of water from the ground water lens, water shall be extracted in a way that it does not damage the natural water layer of that island.
Use of water from water resources	7.	(a)	The Authority at its discretion may permit the use of water from protected water resources for a prescribed time period during a disaster, in the following situations

			(3) The possibility that an event that is beyond the control of the water provider will damage the water system and run out of water reserves.
		(b)	The procedure and method for use of protected water resource during the situations stated in sub-section (a) of this section, shall be stated in the plan formulated according to Section 6 (b) of this Regulation.
		(c)	If any circumstances stated in subsection (a) necessitates the usage of a protected water resource in islands or land allotted for agriculture and other industrial activities or tourism, and for that purpose, the owner of the place
			must ensure that water is extracted according to Annex 1 of this regulation in a manner that it does not damage

		(g)	The persons using water from a protected water resource in circumstance stated in subsection (a) of this Regulation, shall inform the Authority the details of the plan to return to the previous situation of water usage and shall make effort to return to that previous situation as soon as possible.	
Renewal of the water layer		8.	(a)	All buildings shall be constructed, in a manner that water from the roof of the buildings or the terrace and overflow water from rainwater tanks, fall into a well or drain to the ground through a well or drainage system. Some designs that could be used for constructing such water drainage system has been provided in Annex 2 of this Regulation as a sample.
		(b)	If any existing building has been constructed in contravention of subsection (a) of this section, it shall be compliant in accordance with subsection (a) of this regulation within five years from the date of commencement of this regulation	
		(c)	It is prohibited to connect water from the roof or terrace of any building and overflow water from water tanks to the sewerage system or to discharge or drain it through the sewerage system.	
		(d)	Notwithstanding subsection (a) of this section, without exception to subsection (b) of this section, if a building does not have designated drainage well, pit or area it is	

			not restricted by this Regulation to release on to the road, if excess water from water overflows from the well or the drainage area.
		(e)	Notwithstanding subsection (c) of this section, the regulation does not prohibit the release of water from the roof or terrace into the sewerage system with the permission of the utility service provider if there is no drainage system in place on that island and if the Government declares a flood disaster due to heavy rain.
Infiltration of water collected in the island into the ground due to heavy rain	9.	(a)	The water drainage systems in the islands shall be built in a way that the water accumulated on the roads of the island drains into the ground. The system should be designed as per the design criteria set by Ministry.
		(b)	The road gutters must be built in a way that the water accumulated in the gutter drain into the ground through a connection to the water drainage system. And the materials used to construct the roads shall be conducive to water drainage.
		(c)	Land reclamation projects shall by conducted, in a manner that ensures that flooding does not arise due to the reclamation water drains to the ground in the island. And if that island, has been facing problems of water drainage even prior to land reclamation, land reclamation shall be carried out in a way that does not further exacerbate the issue of flooding.
		(d)	In public infrastructures with open areas such as playgrounds, recreational areas and parks, water drainage systems should be built underground.

Prevention of contamination of water lens due to sewage and wastewater	11.	(a)	In an island, after 1 (one) year of official provision of service after completion of the establishment of the sewerage system, all houses and building on the road wherein the sewerage system pipelines are laid shall be connected to the sewerage system for the purpose of disposal of sewage and wastewater. After the aforementioned period, the drainage of sewage or wastewater to the ground without connecting to the sewerage system by any of those houses or buildings is prohibited.

		(b)	Within 1 (one) year, after the establishment of the sewerage system, the septic tanks and such things used in the island should be safely de-sludged, treated and covered with soil by the utility service provider of sewerage of the island. A price set by the Authority may be charged by the service provider for the provision of this service, from the customer.
		( c)	In the islands where a sewerage system has been established, it is the responsibility of the licensee to ensure that there is no leakage of sewage or wastewater from the system into the ground at any area of the island.
		(d)	In the islands where there is a sewerage system and treatment facility, if treated sewage and wastewater were to be drained into the ground, it shall be done so in accordance with the standards set out in Annex 3 of this regulation and with the written permission of the authority.
		(e)	If water is being drained to ground as stated on subsection (d) of this Section, the party conducting the draining shall formulate a groundwater lens monitoring plan and submit it to authority for approval. This monitoring report shall be submitted to the authority as per the procedure set by the authority.
		(f)	Draining of sewerage water to the ground in contravention of subsection (e) of this section is prohibited.
		(g)	In the islands wherein the sewerage system has not been established, septic tanks shall be constructed according to the guideline in the Annex 4 of this Regulation.
Prevention of contamination of water lens due to oil and chemical used in industrial, economical and public service works	12.	(a)	It is prohibited for any person or party to spill oil or chemicals and similar agent to the ground or water lens. intentionally or by negligence.
		(b)	Tanks constructed to store oil products shall be in accordance with Regulation No: 2015/R-160 (Regulation on the handling, usage and storage of oil products).
		(c)	Oils or any chemical product shall be stored in an area that is adequately sheltered, properly secured with a bund wall and designed in reference to the quantity of oil and chemical stored in that area, in case of a leak, it

	will not drain into the ground, but can be collected and restored.
(d)	Spillage of oil or any chemical products to the ground resulting in the contamination of ground water, due to transportation by land from one location to another, in contravention of Law No: 8/2020 (Water and Sewerage Act) and this regulation is prohibited.
(e)	Oil and chemical refill points shall be established in an area, appropriately sheltered, properly secured with a bund wall, and designed with reference to the maximum quantity of oil and chemical refilling that can be done at the area, hence, in case of a leak of that quantity, it will not drain into the ground, but can be collected and restored.
(f)	Transportation of oil or any chemical products on land shall be done in containers in a way that it does not cause any spillage to the ground. These containers must be attached to the vehicle properly.
(g)	Oil and any chemical products, shall be carried on any vehicle in accordance with Regulation No: 2015/R-160 (Regulation on the handling, usage and storage of oil products).
(h)	If a pipeline is buried underground for the transport of oil or any chemical products, the construction of the pipes shall be carried out after an environmental impact report has been prepared and clearance from Environmental Protection Agency has been obtained.
(i)	Oil and any chemical products shall be disposed, at a place approved by the Authority, in manner that does not contaminate the ground water layer or any other water resource. Any other manner of disposal it is prohibited.
(j)	It shall be the responsibility of oil and any chemical product owners to safely handle oil and chemicals required for disposal in a manner that does not pollute water resources.
(k)	Special sampling points for ground water testing shall be maintained in areas where oil or chemical is stored, refilled, transferred, by persons conducting those works.
(1)	After establishing sampling points, persons handling oil and any chemical products, shall submit to the Authority or person authorized by the Authority, before the 10 <sup>th</sup> day of the first month of each quarter, after testing the below stated perimeters. (d)	A person who uses unauthorized water and sewerage services, shall be punishable with a fine of not more than 1000,000/- (one million) Maldivian Rufiya.
(e)	A person from whom the Ministry has requested information from, and without reasonable cause fails to provide the requested information within the time frame given by the Ministry, shall be punishable with a fine of not more than 5000/- (five thousand) Maldivian Rufiya
(f)	A person who opens, shuts or make changes to a valve, stopper or manhole installed by the sewerage service provider for the provision of sewerage service, shall be punishable with a fine between 1000/- (one thousand) Maldivian Rufiya and 25,000/- (twenty-five thousand) Maldivian Rufiya.
(g)	A person who for the production of water, uses water from the freshwater layer of the island or natural wetland or lake, shall be punishable with a fine between 500,000/- (five hundred thousand) Maldivian Rufiya and 1000,000/- (one million) Maldivian Rufiya
(h)	A person who, intentionally or by negligence, puts in the water system anything or lets anything to reach into the system that may cause any change in the quality of the water provided by the service provider, shall be










INFILTRATION GALLERY (REAR VIEW)

#### Guideline on preparing cesspit, septic tank and drainage pit.

#### 1. Cesspit

#### (a) Determining a place

Cesspit and drainage pit shall be kept as far as possible from the water well. It should be ensured that at least 15 meters are maintained between the water well and cesspit and between the water well and drainage pit. And if there are two drainage pits, it should be ensured that at least 10 meters is maintained between them.


#### (b) Avoidance of sewage seepage

It is very important to keep the cesspit closed to ensure that there is no leakage. That is if sewage from tank seeps or leaks into the ground, the sewage will contaminate the groundwater. For this reason, a waterproofing agent (compound) should be added to the bottom (base) and top (top cover) of the tank if available, when preparing the required concrete. Once the tank is completed, it should be filled with water before use and tested for any leaks from any part of the well.

#### (c) Building a strong cesspit

Cesspit shall be strong enough to hold the weight of the sewage and wastewater discharged into it. The weight of 1 liter of water is 1 kilogram. Therefore, a 2000 liter tank that is half full will weigh 1 ton. The base of the pit shall be made of concrete and steel, through the insertion of a steel rod. Inserting 9mm steel rod from each 200mm will be favorable. The tank's base must be constructed on the ground using formwork. After leveling the bottom of the excavated pit, the concrete base will be poured on it. The figure below depicts how the bottom of the pit should be.



#### (d) Preparing the cesspit in the correct measurements and completing its parts

Cesspit shall be prepared, according to the measurements shown in the drawing. This is a good a measurement to fit in a squat toilet, in a household of 8 people. This cesspit shall be emptied in every 5 (five) years. If it is used by more than 8 people or if flushing toilet (sitting toilet with tank) is used, the cesspit shall be emptied in every 3 (three) years. It should be in rectangular shape with two compartments. The first compartment shall be twice the size of the second compartment. The drawing shows how to prepare a proper cesspit with all the necessary parts.




- The tank will work properly when the measurements are used according to the information in the drawing.
- The length of the tank shall be twice as long as its breadth.
- The first lid shall be twice the size of the second lid.
- The tank should be concreted. If cement block is used for the construction of the tank, it should be coated with 20mm thick cement mortar.
- The pipe connecting the cesspit to the toilet, should be slanted from 1 to 50. For example, in a pipe of 200 cm long, slant level should be of (200/50=4) cm.
- The pipe connecting the cesspit to the drainage pit should also be slanted to that level.

#### (e) Proper preparation of the drainage pit

The water wells near the underground freshwater layer can be protected, if the drainage pit for sewage to pass through is prepared well. When the wastewater is passed out of the cesspit into the dry soil beneath, the drainage pit will drain it, therefore the bottom of the drainage pit shall be at least half meter above the ground water layer. Hence, it is best to keep the drainage pit as shallow as possible without deepening. The pit should also be large enough to enable all wastewater that pours into the drainage pit, to drain properly into the underground. A pit of length 5-meter, width of half meter and depth of half meter shall be adequate for an ordinary household. Drawing 3 shows the proper design of a drainage pit and the parts that should be included. Each of these parts is important for the proper functioning of the drainage pit. Hence, all those parts should be included. It will be useful to cultivate plants such as chili, bamboo, red banana near the drainage pit. The roots of these plants will help in purifying wastewater.

#### 2. Septic tank


## (a) Preparation of septic tank

- (1) The septic tank should be installed, as far as possible from the water well. Between the nearest water and the septic tank, there shall at least be 15 meters.
- (2) Dig a pit large enough to hold a tank shown in drawing 4, level and harden the soil at the bottom of the pit.
- (3) Concrete the bottom of the tank by placing plywood formwork near the pit. While concreting insert steel rod (crisscross) from each by 200 mn
- (4) When the concrete bottom is dry, insert into the pit and level it. Afterwards, the walls of the tank can be prepared with concrete or built with stone. While preparing the walls, pipes going in and out should be inserted. Before inserting these pipes, apply glue to the outside of the pipe, to the level to be inserted into the wall, and coat with sand. The purpose of this is to connect the pipe and wall properly and seal it.
- (5) The cross wall between the two compartments of the tank can also be concreted. Or if preferred it could be built. There shall be two holes of 100 mm in this wall in order for the wastewater to pass from the first compartment into the second compartment.
- (6) Prepare a "T" or "elbow" from 100 mm PVC pipe and attach to the tank. To attach properly apply PVC glue and coat with sand.
- (7) It is important to attach a "baffle" to prevent particles floating in the water from going inside the pipe. And the use of a "T" here will make it easier to clean the pipe through insertion.


(8) Inside of the tank (on the walls), shall be covered with cement of 20 mm thickness. For this purpose, "sulphate resistant" shall be used. And if available, "bituminous paint" can be applied to make it waterproof.

- (9) The lid of the tank should also be prepared on the ground using formwork. While preparing the tank lid, there shall be 2 holes of 600 mm diameter on the tank lid. And small lids to be placed on these holes shall also be prepared.
- (10) Inside of the tank lid shall be covered with sulphate resistant. And it should be cemented and painted with bituminous paint.
- (11) In the pipe connecting the toilet and the septic tank, a septic vent pipe shall be installed as near as possible to the toilet. The septic vent pipe shall be of the height 4 (four) meters and shall be attached to a wall.


Drawing: 4 (a) - Top view

## (b) Testing the septic tank

- (1) To test the tank for leaks, pour water into the tank and leave it. Check after 6 hours and if the water has lessened, it means there is a leak. If that happens, find the leak, seal the area with cement and apply bituminous paint.
- (2) To check if the septic vent pipe works, put a lighted paper inside the tank. When done so, if the vent works, the smoke shall travel through the pipe connected to the tank and come out of the septic vent pipe.

#### (c) The drainage pit connected to the septic tank

(1) The drainage pit shall be as far as possible from the water wells. It should be at least 15 meters away from the nearest well. And it should be 10 meters away from the other drainage pits.

- (2) Cut a PVC pipe of 100 mm to the width of two hack saw blades. Between each cutting a length of 100 mm shall be maintained.
- (3) Dig a pit, half meter deep, from the water outlet pipe of the septic tank. The width of this pit must be half meter and 5 meter of length shall be maintained. Small pebbles must be kept inside the pit and this shall be done to the level of the water outlet pipe of the septic tank.
- (4) Connect the PVC pipe cut to the width of two hack saw blades, to water outlet pipe of the septic tank and place it in the pebbled, leveled. After that, again place pebbles on the pipe to the thickness of 50 mm.
- (5) Place, such as nylon sacks on the pebbles. This is to avoid soil from entering into the pit. Transfer the soil which was removed while digging the pit, into the sacks and level it to the ground.

## (d) Proper maintenance of the septic tank

After the preparation of the cesspit and drainage pit, attention shall be given to regular maintenance during usage.

## (e) Desludging the cesspit connected to the septic tank

If a tank prepared, according to the measurements shown in the drawing 4, is used by a household of 8 people, it shall be emptied in about every 5 (five) years. The level of sludge in the tank shall be checked intermittently. This can be done by lifting the removable lid and by the insertion of a stick. The tank is full when the increase in sludging reaches the bottom of the T attached to the pipe for carrying in sewage into the septic tank. If the sludge reaches above this, it may block the pipe for carrying in sewage and water into the tank, causing flooding of toilets. When removing the lid of the tank, a thin layer of sludge may be observed which is a common occurrence. This thin sludge layer will enable disposal of sewage and it shall not be destroyed unless during the event of emptying the tank.

## (f) Disposal of sludge in the septic tank safely

Mud (sludge) removed from septic tanks, may have an adverse effect on health. As such, it should be disposed of in a correct and safe manner. The transfer of the sludge from septic tank to the disposal area shall be done cautiously and in a container like empty oil barrel, that can be properly sealed.

## (g) Emptying sludge from the cesspit

Since, gases formed in the cesspit are dangerous to health and contain life-threatening hazardous substances, a person should not climb into it unless otherwise required. Even in such a situation, after opening the lid of the tank, it shall be left open for at least 1 (one) hour, before entering. And the person shall not stay inside the tank for more than 10 minutes. If working inside the tank, another person must stay close by for assistance to help climb out of the tank, in case of headache or dizziness due to gas. The best way to empty sludge from a cesspit is by using a pump.

Below stated is the procedure for emptying sludge from the cesspit.

- 1. Find a container or similar item in which sludge or sewage can be sealed properly and carried easily.
- 2. Remove both the lids of tank.
- If there is water in the first compartment, remove the water with an item such as a ladle, and pour it into the second compartment and close the lid of the second compartment afterwards.
- 4. Next, remove the sludge from the first compartment and put it into the designated container. Continue to do this until the greater portion of the sludge is removed.
- 5. Fully emptying the tank of sludge is not appropriate. Hence, sludge must be kept at the bottom of the tank to a thickness of 100mm. If the tank is emptied of sludge, it may destroy the germs responsible for disposal of sewage.
- 6. It is not proper to wash the tank using chemicals like chlorine as it may kill the germs.
- 7. During the time in which the tank is open, if there is oil or such fat present near the sewage in and out pipes, it should be removed.
- 8. After the cleaning process, place the first lid and seal it properly. Afterwards, if there is any spillage of sludge outside the tank, clean properly and wash with chlorine water.
